Suspect arrested after leading officers on pursuit in Fontana on Oct. 6

A suspect was arrested after he led Fontana Police Department officers on an early-morning pursuit throughout Fontana on Oct. 6.

An officer attempted to stop the driver of a gray Honda Accord in the area of Slover Avenue and Cedar Avenue for a traffic violation. When the driver failed to stop, a pursuit ensued northbound on Cedar.

The suspect entered the westbound Interstate 10 Freeway and then exited onto northbound Sierra Avenue. The pursuit continued northbound on Sierra, and the driver turned eastbound onto Valencia Avenue.

But at that point, the driver lost control of his car and collided with the curb and sheared off the right front tire of his car in the 17100 block of Valencia, where the pursuit ended.

No police officers were injured in the pursuit.

Authorities said that 26-year-old Juan Martinez was arrested on charges of felony evading and DUI. A female passenger in the car was not arrested.

San Bernardino County Fire Department medics treated the suspect for a complaint of pain and he was transported to a local hospital.

The Fontana P.D. is handling the investigation.

THREE INJURED IN TWO-VEHICLE CRASH IN TWENTYNINE PALMS SATURDAY

Three people were injured, two seriously, in a traffic collision in Twentynine Palms Saturday night. According to the Sheriff's Department, a Chevrolet Silverado was traveling northbound on Lear Avenue when

it collided with a Nissan Altima that was making a left-hand turn from Two Mile Road onto southbound Lear Avenue. The force of the collision resulted in the Silverado landing upside down on its roof. When **Twentynine Palms firefighters** arrived, they saw smoke coming from one vehicle, but no active fire. A woman inside the Altima had to be extricated by firefighters; she and the man in the Altima were taken by Morongo Basin Ambulance to the landing zone at Hi-Desert Medical Center and then flown to area trauma hospitals with serious injuries. The man in the Silverado was taken by MBA to Desert Regional Medical Center in Palm Springs.

It's time to get moving. Fontana's annual Let's Move on the Trail event will be held Saturday, Oct. 12 in the downtown area.

The event will provide free resources, games, live demonstrations by the Fontana Police Department and **San Bernardino County Fire** Department, and additional opportunities to enjoy a healthy and fun morning.

The event will take place from 9 a.m. to 1 p.m. between the blocks of Cypress Avenue and Mango Avenue. The event kicks off with a 2.2-mile family walk/run event and a 5-mile bike ride. To register for the walk or bike ride, visit www.healthyfontana.org.

The Pacific Electric Trail (PET) offers seven miles of opportunity to be physically active for better health as well as connectivity to local schools, businesses, and community centers. Let's Move on the Trail is a free community event that highlights the PET and engages participants in numerous resources and activities, including art and fitness expos and healthy food options.

The family walk/run, in conjunction with Healthy Rialto, will begin at North Cedar Avenue and the PET, and the bike ride will begin at North Heritage Circle. Both the walk and bike ride will begin at 9 a.m. and end at Miller Park Amphitheater. This year, those who register for the events can receive a free event T-shirt and bike helmet, while supplies last.

A variety of resource vendors will line the PET, including Animal Services, Friends of the Lewis Library, local dentist offices, San Bernardino County programs, and West Valley Water District, to name a few.

Central City Community Health Center will also have a mobile clinic at the event, offering free glucose and iron screenings.

Participants can stop by the Art Depot for crafts, engaging chalk wall art, and free frozen fruit bars.

“This is a great event for the whole family to get to know your community while picking up a wide variety of free resources. All this, while having fun,” said Community Services Coordinator Jasmine Sarsadias.

Van crashes into children’s dental office in Hesperia, no serious injuries reported

HESPERIA, Calif. (VVNG.com) No serious injuries were reported Friday afternoon after a van plowed through a building Friday afternoon.

It happened just after 3pm on the 15200 block of Bear Valley Road near Locust Avenue, at the Desert Dental Group Children’s Center.

The call was dispatched as a person trapped following the crash, but when firefighters from the **San Bernardino County Fire** Department arrived, they determined that one person suffered only minor injuries.

Emergency personnel requested the response of Building and Safety to ensure the structural integrity of the facility.

According to staff at Desert Dental Group, the Children’s Dental Center will be closed for the remainder of the day.

“We’re thankful nobody was injured, especially since there were people just walking out of the building,” a staff member told VVNG.com

Adelanto House Fire Leaves One Injured

ADELANTO, Ca. – The cause of an Adelanto house fire on Friday morning is being investigated, while one person is currently being treated for burns.

At around 6:40 p.m., a report regarding a fire in the 1100 block of Live Oak was made. When **San Bernardino County firefighters** arrived they found heavy fire and smoke billowing from the single-story home. Firefighters quickly learned that the fire spread to the attic and responded accordingly to limit damage and while searching the home for any possible occupants.

Firefighters were able to put the fire out and one civilian was transported to a local hospital for treatment. Fire officials said that both the primary and secondary searches came back clear. No fire personnel was injured. The cause of the fire has not been released at this time, fire officials said.
