Firefighters extinguish house fire on Long View Avenue in Hesperia

HESPERIA — **San Bernardino County Fire Department** personnel extinguished a structure fire in the 8400 block of Long View Avenue in Hesperia on Wednesday.

While the cause is still unknown, San Bernardino County Sheriff's Department spokeswoman Cindy Bachman said the department's Narcotics team was handling the investigation after evidence of a THC extraction lab was found inside the home.

Responding to multiple calls of a blaze at a single-story home in the area, firefighters arrived at approximately 11:30 a.m. to find the garage fully involved with flames and smoke and the fire having made their way into the attic, authorities said.

County Fire Battalion Chief Bill Mahan told the Daily Press that firefighters went into attack mode and had to open up the roof of the home — the roof of the garage had collapsed — to help with ventilation.

No residents were home at the time of the fire, according to Mahan, but one man was taken to a local hospital for a minor burn to his nose.

Long View Avenue, from Pleasant View to Cedar streets, was closed for several hours as authorities investigated the blaze.

Further details on the blaze weren't available late Wednesday, and the fire remains under investigation.

Firefighters Respond to House Fire Near Cedar Middle School

HESPERIA, Calif. (VVNG.com) **San Bernardino County Fire** responded to a house fire near Cedar Middle School in Hesperia Wednesday morning.

At about 11:19 a.m. dispatch received reports of a garage on fire in the 8400 block of Long View Avenue with possible explosions heard, per scanner reports.

\Firefighters arrived and located a single story residence with the garage fully engulfed in flames. Firefighters are currently in the attack mode and working on knocking down the blaze that's extended into the attic of the home.

The fire is not posing any threat to students or staff at Cedar Middle School.

The cause of the fire is currently under investigation.

At about 11:50 a.m. medical was requested to treat a patient with "minor burns", per scanner traffic info.

A fire burned two to three acres of vegetation Wednesday along the Santa Ana River bike trail in Colton.

Firefighters were dispatched about 1:45 p.m. to the area of the bike trail, just west of Mount Vernon Avenue, according to the Colton Fire Department's Facebook page.

The fire was quickly contained and no structures were damaged, according to the Facebook page of Redlands Fire Department, which responded to the location to assist. No injuries were reported.

Assistance was also provided by Loma Linda and **San Bernardino County fire** departments. Hours later, fire crews were still at the location, mopping up hot spots.

Pedestrian Struck by Vehicle on Mojave Drive in Victorville

VICTORVILLE, Calif. (VVNG.com) A woman suffered major head trauma after she was struck by a vehicle Wednesday afternoon.

At about 3:31 p.m. dispatch received reports of a vehicle versus pedestrian on Mojave Drive between El Evado and Ashley Glen Drive.

San Bernardino County Fire along with San Bernardino County Sheriff's responded and located a White female adult down in the roadway.

When medical personnel arrived, the woman's face was visibly covered in blood as she hugged her teddy bear.

Due to the pedestrian's injuries, an airship was requested. The woman was transported by ground ambulance to Victor Valley Global Medical Center and subsequently airlifted to Arrowhead Regional Medical Center.

A woman at the scene told Victor Valley News, the woman was talking to herself while pushing a stroller with no baby in it prior to the incident.

According to authorities, the woman was walking along the sidewalk on the west side of Mojave Drive when for unknown reasons she attempted to run across traffic.

The female driver of a white Dodge Ram pickup truck was unable to avoid striking the pedestrian.

The driver of the Ram truck remained at the scene and cooperated with authorities. Westbound traffic on Mojave Drive was temporarily closed at Ferndale Road.
