## Early morning fire causes \$250,000 damage to San Bernardino house

A fire early Tuesday, Nov. 15, caused an estimated \$250,000 worth of damage to a San Bernardino home, authorities said.

Nobody was inside the home during the fire, **San Bernardino County Fire Department** officials said in a news release. The fire - which caused "heavy damage" to the home - was knocked down in about 30 minutes, the news release said.

Firefighters arrived at the 2,500 square foot home in the 100 block of East Dumas Street - near the Inland Regional Center - seven minutes after the fire was reported at 3:05 a.m., the news release said. Heavy smoke and fire were "showing from multiple sides" of the home, and threatened an additional home. The firefighters also found a downed power line behind the home and cordoned off the area.

Firefighters battled the blaze from inside and outside the home, the news release said. A large "add-on" was found behind the home.

Firefighters searched the home and confirmed nobody was inside.

The cause and origin of the fire remain under investigation, the news release said.

## Pedestrian killed in Monday night collision on Amargosa Road

VICTORVILLE — Two separate collisions involving pedestrians in Victorville Monday left a Victorville man dead and a woman in a local trauma center with major injuries, authorities said.

**San Bernardino County Fire Department** spokesman Mike McClintock said authorities responded to the first collision at approximately 5:43 p.m.on Amargosa Road near Midtown Drive.

San Bernardino County Sheriff-Coroner officials identified the man as Stacey Howard, 46, and said he was pronounced dead at the scene at approximately 5:52 p.m. According to the coroner's report, Howard was struck by a van heading south as he crossed Amargosa Road.

Authorities responded to the second pedestrian collision of the night a little after 11:10 p.m. and found a woman was struck by a sedan as she crossed Seventh Street near Tatum Road.

McClintock said the woman was airlifted by Mercy Air to a trauma center with "immediate" injuries.

Victorville Sheriff's Station spokeswoman Mara Rodriguez said additional information on the crashes was unavailable Tuesday morning.

The collisions were under investigation by the Sheriff's Major Accident Investigation Team.

## **Bizarre Circumstances Surround Fatality In Twentynine Palms House Fire Z107.7 News**

A bizarre set of circumstances surround a house fire in Twentynine Palms Monday, where a man was found hanged and shot. **County Fire** Battalion Chief Mike Snow said firefighters were called to the 7400 block of Persia at 4:12 p.m. Firefighters from Twentynine Palms, Joshua Tree, Wonder Valley, Yucca Mesa, and the Combat Center arrived to find the home engulfed in smoke and flame. The fire started in the rear bedroom, and during a sweep of the home, Snow said firefighters found the victim hanging in the front bedroom. He had also been shot. According to Snow, family members told fire personnel that the victim had a history of health problems. Firefighters knocked down the blaze in about 30 minutes. The death and cause of the fire is under investigation.
