Bobcat Fire Information

San Bernardino County Fire continues to monitor the Bobcat Fire burning in Los Angeles County / Angeles National Forest. San Bernardino County Fire Chief Officers are embedded both at the Command Post and in the field monitoring the fire's progress. We have 10 Engines deployed on the fire and Chief Officers in the field monitoring the fire's progress and threat to San Bernardino County communities. Our stations remain fully staffed and ready for an emergency.

The fire is burning 7-8 miles west of the San Bernardino / Los Angeles County line. The fire was very visible last night from Wrightwood, Pinon Hills and other desert communities.

We encourage our residents to sign up for the TENS (see below), have a plan and be prepared to evacuate if an "Evacuation Order" is put in to play.
