Pedestrian hit on Highway 395 in Adelanto Tuesday night

ADELANTO, Calif. (VVNG.com) —A male pedestrian attempting to cross Highway 395, about 200 feet away from the crosswalk at Palmdale Road, was struck by a white Yaris Tuesday night.

San Bernardino County Sheriff's deputies were dispatched to a vehicle versus pedestrian traffic collision just before 9 p.m.

Medic Engine 311 and 313 from the Victorville Fire Department responded along with battalion chief 4311 and AMR, Fire Captain Torres from the Victorville Fire Department told Victor Valley News.

When firefighters arrived on scene they determined the crash to be just north of Palmdale Road on Highway 395 near the Panda Express restaurant, Captain Torres confirmed.

Captain Torres said the man was responsive and alert when they arrived on scene, but as a precaution, he was transported to Loma Linda University Medical Center by ground ambulance.

Although the jurisdiction of the crash was in Adelanto, Victorville Fire provided mutual aid to Adelanto which is typically serviced by **San Bernardino County Fire**.

According to a witness, the pedestrian was crossing from the east side of Highway 395 leaving the Panda Express and walking back to a tractor-trailer across the highway when he was struck by a white Toyota Yaris.

The female driver of the compact sedan involved in the collision remained on scene and cooperated with deputies. The vehicle was also occupied by her child son.

Neither occupants in the vehicle were injured.

The car was traveling at speeds of about 40 miles per hour when the crash occurred, witnesses said.

Northbound Highway 395 was temporarily closed while debris was cleared from the road.

UPDATE @ 4:20 p.m. — Due to high winds, the helicopter was unable to land, and instead, the victim was transported by ambulance to ARMC.

CAJON PASS, Calif. (VVNG.com) — A crash involving a semi and a vehicle prompted firefighters to temporarily shut down the I-15 freeway Tuesday afternoon.

It happened at 3:22 pm, on the northbound I-15 freeway, about a mile and a half from Oak Hill Road in the cajon pass.

According to the California Highway Patrol incident logs, a red Ford Fusion slammed into the back of a tractor-trailer and a male with a head-injury was down on the roadway.

An off-duty LACO Sheriff Deputy on scene was performing CPR on that male, per the logs.

San Bernardino County Fire arrived on scene and determined they had two occupants from the vehicle requiring medical attention.

Due to the severity of injuries, firefighters requested County helicopter H325 to respond and land on the 15 freeway.

An occupant from the vehicle was flown to Arrowhead Regional Medical Center with life-threatening injuries. A second person was transported by ground ambulance to ARMC.

The cause of the crash is under investigation by the California Highway Patrol. Additional information will be updated as it becomes available.

Collision slows traffic on I-15

CAJON PASS — A multiple-vehicle crash that sent two people to the hospital snarled traffic here on the northbound 15 Tuesday afternoon.

According to California Highway Patrol logs, around 3:32 p.m. CHP dispatch received a report of a semi-truck with a trailer colliding with a red sedan 1.5 miles before Oak Hill Road.

The red Ford Fusion and a second unknown vehicle were reported to be blocking multiple lanes, with two people out of a vehicle laying on the side of the roadway.

One person was reported to be suffering from a head injury and passing out.

According to the logs, a collision between a silver vehicle and white Acura also occurred, but whether it was part of the same crash, a CHP official couldn't confirm.

An off-duty Los Angeles County Sheriff's deputy was reported to be doing CPR at the scene.

San Bernardino County Fire spokesperson Eric Sherwin told the Daily Press firefighters requested a helicopter to transport a patient.

Scanner traffic indicated it wasn't able to land due to high winds which were reported with gusts up to 20 mph.

Two people were taken by ambulance to Arrowhead Regional Medical Center with life-threatening injuries, Sherwin said.

CHP issued a Sig Alert around 4:16 p.m.

As of 6:19 p.m., Caltrans District 8 tweeted that the number 5 lane, designated for trucks, was still blocked.
