1 person critically injured in rollover crash on Air Expressway in Victorville

VICTORVILLE, Calif. (VVNG.com) — One person was airlifted following a crash here Monday night. It happened at 6:42 p.m. on Air Expressway, just west of Turner Road.

San Bernardino County Firefighters responded and found a Ford sedan on its roof. A second vehicle with passenger side damaged was parked nearby.

One person from the Ford suffered major injuries and two other occupants declined medical treatment.

SBCOFD's helicopter landed at the United States Penitentiary in Victorville to further airlift the critically injured victim to a trauma center.

Hesperia City Council meeting: What to watch for

HESPERIA — The City Council will meet at 6:30 p.m. Tuesday to discuss a short list of agenda items including:

- An increase to a current contract with Layne Christensen for water pump repair services in the amount of \$100,500, and with a new not-to-exceed amount of \$204,500. Christensen provides well maintenance for the various sites operated by the District that has 17 wells and six booster stations to purvey water throughout the city.
- The approval of an amended agreement between the city County Service Area 64 to facilitate the extension of sewer service by CSA 64 to the south to serve property within the city's boundary located on the southern portion of Bear Valley Road near Fish Hatchery Road in Hesperia. The property owner and applicant Rich Development have requested a conditional use permit to develop a shopping center on a parcel located near the area.
- The adoption of a resolution that would implement Hesperia Community Development Commission members stipends as prescribed by the California Health and Safety Code. The commissioners oversee all aspects of the HDCC, which includes the negotiation of land sales; annual budget approval, quarterly amendments; receiving and filing the annual audited financial report; and receiving and filing the SB 341 Compliance Report, which details the low and moderate Income housing assets fund

of the former Redevelopment Agency. Upon approval, each HCDC member will receive \$75 for each meeting attended with no more than two meetings scheduled per month.

- A resolution that would establish the time and place of regular meetings for the Fire Protection District resulting from the annexation and reorganization to the County of San Bernardino. In Nov. the Hesperia Fire Protection District was annexed into the County Fire District, with a condition requiring that the HFPD retain the CalPERS retirement obligations attributed to the HFPD's CalPERS plan for all suppression, prevention and administrative HFPD employees.
- The approval of an amendment to the term loan agreement contract between the city and the San Bernardino County Transportation Authority related to the construction of the Ranchero Road and Interstate 15 Interchange Project. The development of the agreement would begin the repayment period that was delayed almost two years until a refund from Southern California Edison was paid to the City and the final reconciliation of total project costs could be determined. The final cost and remaining local share balance owed to SBCTA of nearly \$18.7 million.
- An amendment to the professional services agreement between the city and Parsons Transportation Group, Inc. in the amount of \$543,259 for a total amount of \$3,603,259. The increase is for the Ranchero Road Widening Project and the "G" Avenue Rail Lead Track Project. Over the years, the city has contracted with Parsons for preliminary engineering, studies, design, and construction management services for various capital improvement projects.
