A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NEEDLES, CALIFORNIA, RESCINDING RESOLUTION NO. 2012-28 AND ORDERING THE SUBMISSION TO THE QUALIFIED ELECTORS OF THE CITY OF A CERTAIN MEASURE RELATING TO THE ADOPTION OF A GENERAL UTILITY USERS TAX AT THE GENERAL ELECTION TO BE HELD ON TUESDAY, NOVEMBER 6, 2012

WHEREAS, a general election on Tuesday, November 6, 2012 has been called by Resolution No. 2012-22, adopted on June 12, 2012, and

WHEREAS, the City Council also desires to submit to the voters at the election a question relating to the adoption of a general Utility Users Tax.

WHEREAS, the City Council approved resolution No 2012-28 at its July 10, 2012 meeting and now wishes to rescind that resolution and adopt this resolution ordering that Ordinance 545 AC be placed on the November 6, 2012 ballot for submission to the voters.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF NEEDLES, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. Resolution 2012-28 is hereby rescinded (inclusive of Attachment A, Ordinance 544-AC) and Pursuant to Elections Code section 9222, ordinance number 545-AC (an ordinance establishing a utility users tax) shall be submitted to the voters at the City's next regular municipal election on November 6, 2012.

SECTION 2. The City requests and authorizes the San Bernardino County Board of Supervisors to consolidate the election on the utility users tax measure with the Statewide election on November 6, 2012.

SECTION 3. Pursuant to Elections Code section 10403, the ballot forms shall have printed on them the following words with regard to the measure:

Shall Needles eliminate 2.5% of the current 7.5% franchise fee that the City of Needles charges the Needles Public Utility Authority and	YES
in its place establish a utility user tax of up to 2.5% to be applied to electric, water and sewer use charges?	NO

SECTION 4. The complete text of ordinance number 545-AC is attached hereto as Exhibit A.

SECTION 5. In all particulars not recited in this resolution, the election shall be held and conducted as provided by law for holding municipal elections.

SECTION 6. Notice of the time and place of holding the election is hereby given and the City Clerk is authorized, instructed and directed to give further or additional notice of the election, in time, form and manner as required by law.

SECTION 7. The City Manager and City Clerk are hereby authorized and directed to take all necessary and appropriate steps to place the measure on the ballot.

SECTION 8. The City Clerk shall certify to the passage and adoption of this Resolution and enter it into the book of original Resolutions.
