### **RESOLUTION NO. 2013-34**

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF APPLE VALLEY, CALIFORNIA, SETTING RULES AND PRIORITIES FOR FILING WRITTEN ARGUMENTS REGARDING A TOWN MEASURE

WHEREAS, a Special Municipal Election is to be held in the Town of Apple Valley, California on November 19, 2013, at which there will be submitted to the voters the following Measure:

"Shall a General Plan Amendment be adopted, and shall

southeasterly corner of the intersection of Dale Evans	
Parkway and Thunderbird Road?"	

NOW, THEREFORE, THE TOWN COUNCIL OF THE TOWN OF APPLE VALLEY, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. ARGUMENTS. That the Town Council authorizes (i) all members of the Town Council, (ii) any individual voter eligible to vote on the above Measure, (iii) a bona fide association of such citizens or (iv) any combination thereof, to file a written argument in favor of or against the Measure, accompanied by the printed name(s) and signature(s) of the author(s) submitting it, in accordance with Article 4, Chapter 3, Division 9 of the Elections Code of the State of California, and to change the argument until and including the date fixed below by the Town Clerk, after which no arguments for or against the Measure may be submitted to the Town Clerk.

The deadline to submit arguments for or against the Measure pursuant to this Resolution is declared by the Town Clerk to be **August 27, 2013, at 5:00 p.m.** 

Each argument shall be filed with the Town Clerk, signed, and include the printed name(s) and signature(s) of the author(s) submitting it, or if submitted on behalf of an organization, the name of the organization, and the printed name and signature of at least one of its principal officers who is the author of the argument.

In the event more than one argument is submitted either for or against the Measure, the Town Clerk shall select only one argument for each side to be placed in the ballot pamphlet, all in accordance with the priorities set forth in the Elections Code of the State of California.

SECTION 2. PRIOR RESOLUTIONS. That all previous resolutions providing for the filing of primary arguments related to Town measures are repealed.

SECTION 3. NOVEMBER 19, 2013 ELECTION. That the provisions of Section 1 shall apply only to the election to be held on November 19, 2013, and shall then be repealed.

SECTION 4. CERTIFICATION. The Town Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original Resolutions.
