

REBUTTAL MEASURE I

Vote NO on Measure I

Fontana Herald's 8-26-16 article "Etiwanda School District puts bond measure on the ballot" states "the district is in the process of constructing its 13th elementary school". Board Member Mondy Taylor is on videotape 10-21-15 saying "we have this school #13 right here on the horizon, we are building it and we are praying that maybe we can get some bond money back but even in the facilities report that you gave us (Clafin), we might still have to build two schools and there will be no money left". This bond says nothing about construction of new schools but that is precisely what the board discussed.

Vote NO on Measure I

Voters deserve honesty and transparency. The voters should not approve a bait and switch BOND to pay for construction of new schools based on population projections that are flawed. Citing Westgate Development, the assistant superintendent Doug Clafin, in his staff report used the figure of 5,500 units to forecast future schools. Westgate was rejected by Fontana planning commission.

A bond that is based on false data and which will burden owners with more TAXES should NOT be approved.
