

Voting Instructions

Marking your official ballot

- 1. Use a BLACK or BLUE pen or a #2 pencil.

Example:



- Do not vote for more candidates than the number indicated for each contest. If you vote for more, your vote will not count for that contest.
- 4. To vote for a candidate whose name is not on the ballot, print the name of the candidate on the blank write-in line and connect the arrow pointing to that candidate.
- If you make a mistake or damage your ballot, request a replacement ballot.

MEASURE J CITY OF BARSTOW

IMPARTIAL ANALYSIS OF MEASURE J

This Impartial Analysis of Measure J has been prepared by the City Attorney pursuant to Section 9280 of the California Elections Code.

Measure "J" would adopt a transactions and use tax in the City of Barstow at the rate of one-half cent for every dollar spent (or 0.5%). This kind of tax is often called a sales tax. The proceeds of this tax would be placed in a special City fund to be used to support fire protection and paramedic emergency response for the Barstow Fire Protection District, including salaries and benefits for qualified firefighting and paramedic personnel, repayment of debts and the repair and replacement of fire protection equipment.

The tax would be in addition to existing sales tax, and it would be levied on the sale or use of tangible personal property sold at retail. Retailers collect the tax at the time of sale and remit the funds to the State Board of Equalization, which administers the tax. Tax proceeds cannot be confiscated by the state.

The Barstow City Council placed Measure "J" on the ballot. Because Measure "J" limits the purposes for which the tax revenue can be used, it is a "special tax" requiring two-thirds voter approval. If approved, the tax will remain in effect until amended or repealed by the voters, or until the Barstow Fire Protection District is transferred to an agency outside the City of Barstow.

A "yes" vote is a vote in favor of authorizing the one-half percent transactions and use tax.

A "no" vote is a vote against authorizing the transaction and use tax.

MEASURE K CITY OF <u>VICTORVILLE</u>

IMPARTIAL ANALYSIS OF MEASURE K

This Impartial Analysis of Measure K has been prepared by the City Attorney pursuant to Section 9280 of the California Elections Code.

Measure K asks voters to approve an ordinance enacting a one half-cent (0.5%) special transactions and use (sales) tax within the City of Victorville. This special tax is restricted to funding public safety services in Victorville in accordance with an expenditure plan that includes the addition of 10 new police officers and 15 new firefighters/paramedics to the City's forces; opening Fire Station 315 near Sunset Ridge Park; equipment, training and support for these additional personnel; and acquiring life-safety apparatus for fire services. The tax revenues (an estimated \$8.5 million per year) will supplement, not replace, existing City public safety services expenditures as reflected in Victorville's FY 2017/2018 budget, and cannot lawfully be used for any other purpose.

Currently, State and local retail sales tax in Victorville is 7.75% of the purchase price; but Victorville only receives 1% of this amount. The remainder goes to the State and the San Bernardino County Transportation Authority. Measure K would increase the current total sales tax rate in Victorville from 7.75 to 8.25%, *i.e.*, would add a half cent to the price of an item that costs a dollar. If adopted, collection of the tax is expected to commence April 1, 2018.

Technically, the existing sales tax is a combination of "sales and use tax" and "transactions and use tax." Retailers collect both taxes at the time of sale and remit the funds to the California Department of Tax and Fee Administration, which administers the taxes. Both are levied on the retail sale or use of personal property, with certain exceptions.

The special tax will be collected where the sale is made in Victorville or where the goods are delivered and placed into use in Victorville. Merchandise purchased in a "walk-in" retail store is assumed by the State to be used within the city in which the store is located and the applicable tax will be paid by both residents and nonresidents, unless the retailer is asked to ship the merchandise outside the city as part of the sale or it is a motor vehicle (which is taxed based on the city of registered use). Certain necessities of life, including purchases of food or medicine, are exempt from the tax.

Measure K requires annual City Council review and re-adoption of an expenditure plan consistent with the ordinance's mandate, as well as annual verification by the City's independent auditor to ensure the tax revenues are being used for the specified public safety purposes. The separate fund or account established for deposit of the tax revenues is further subject to annual audit and reporting in the City's financial statement.

Measure K was placed on the ballot by a 2/3 vote of the Victorville City Council. A "Yes" vote is a vote to approve the additional half cent tax for public safety services in Victorville. A "No" vote is a vote against the tax. Measure K will be approved if it receives a two-thirds (2/3) majority of "Yes" votes.

Voter Bill of Rights

You have the following rights:

 - not in prison or on parole for a felony
- The right to vote if you are a registered voter even if your name is not on the list. You will vote using a provisional ballot. Your vote will be counted if elections officials determine that you are eligible to vote.
- 3. The right to vote if you are still in line when the polls close.
- The right to cast a secret ballot without anyone bothering you or telling you how to vote.
- The right to get a new ballot if you have made a mistake, if you have not already cast your ballot. You can:
 - Ask an elections official at a polling place for a new ballot; or
 - Exchange your vote-by-mail ballot for a new one at an elections office, or at your polling place; or
 - Vote using a provisional ballot, if you do not have your original vote-by-mail ballot.

- The right to get help casting your ballot from anyone you choose, except from your employer or union representative.
- 7. The right to drop off your completed vote-by-mail ballot at any polling place in the county where you are registered to vote.
- The right to get election materials in a language other than English if enough people in your voting precinct speak that language.
- The right to ask questions to elections officials about election procedures and watch the election process. If the person you ask cannot answer your questions, they must send you to the right person for an answer. If you are disruptive, they can stop answering you.
- The right to report any illegal or fraudulent election activity to an elections official or the Secretary of State's office.
