Your San Bernardino County Supervisors make a quarter-million dollars a year while neglecting to do their job.

Deceptive tax increases, uncontrolled spending, increased fees and fines, increased poverty, growing crime, and billions in unfunded pension liabilities. All these underscore the County Supervisors' poor job performance.

With pensions, the county **pretends** to earn more than seven times what is safely available to citizens. In fact, they are **losing** hundreds of millions.
