NOTICE TO VOTERS OF DATE AFTER WHICH NO ARGUMENTS FOR OR AGAINST A CITY MEASURE MAY BE SUBMITTED TO THE CITY CLERK

NOTICE IS GIVEN that the General Municipal Election is to be held in the City of Upland on November 3, 2020, at which time there will be submitted to the voters the following measure:

In order to secure at least \$4,300,000 for the City of Upland to use solely for public improvements to Memorial Park, which may include a new baseball field, additional public parking and other new public amenities, landscaping, structures, and walking trails, shall the City discontinue using approximately 4.63 acres of Memorial Park so it may be sold to San Antonio Regional Hospital to add new facilities and increase capacity for critically-needed medical services? NOTICE IS FURTHER GIVEN that pursuant to Article 4, Chapter 3, Division 9 of the Elections Code of the State of California, any individual voter or bona fide association of citizens, or any combination of voters and associations, may file a written argument titled either "Argument in Favor of Measure ____" or "Argument Against Measure ____", not to exceed 300 words in length, accompanied by the printed name(s) and signature(s) of the author(s) submitting it, or if submitted on behalf of an organization, the name of the organization, and the printed name and signature of at least one of its principal officers who is the author of the argument, for or against the City measure.

NOTICE IS FURTHER GIVEN that, based upon the time reasonably necessary to prepare and print arguments and sample ballots for the election, the City Clerk has fixed, **August 10, 2020 at 6 p.m.**, as the date after which no arguments for or against the City measure may be submitted to the clerk for printing and distribution to the voters as provided in the Article 4. Arguments shall be submitted to the City Clerk, accompanied by the printed name(s) and signature(s) of the author(s) submitting it, or if submitted on behalf of an organization, the name of the organization, and the printed name and signature of at least one of its principal officers who is the author of the argument, at the City Hall, Upland, California. Arguments may be changed or withdrawn until and including the date fixed by the City Clerk.

NOTICE IS FURTHER GIVEN that that if direct arguments are filed, rebuttal arguments titled either "Rebuttal to Argument in Favor of Measure ____" or "Rebuttal to Argument Against Measure ____", not to exceed 250 words in length, may be submitted by the authors of opposing direct arguments, and filed with the clerk, accompanied by the printed name(s) and signature(s) of the author(s) submitted it, or if submitted on behalf of an organization, the name of the organization, and the printed name and signature of at least one of its principal officers who is the author of the argument, not more than 10 days after the final date for filing direct arguments.

NOTICE IS FURTHER GIVEN if more than one argument for or more than one argument against any City measure is submitted, the City Clerk shall select one of the arguments in favor and one argument against the measure, as set forth in Elections Code section 9287.

NOTICE IS FURTHER GIVEN that any proposed ordinance, ballot question, impartial analysis, or direct argument filed under the authority of the Elections Code will be available

for public examination in the Clerk's office for 10-calendar days following the deadline for filing arguments and analysis(es). Any rebuttal argument filed under the authority of the Elections Code will be available for public examination in the Clerk's office for not less than 10-calendar days from the deadline for filing rebuttal arguments.
