RE: Primary Election: Nomination Period Filing Extension

Senate Bill (SB) 594 (Chapter 320 of the Statutes of 2021) revised the 5-day nomination incumbent extension period for the following offices for the June 7, 2022, Primary Election: United States Representative in Congress, Member of the State Board of Equalization, State Senator, and Member of the Assembly. (Elec. Code, § 8168(b)(1).)

Pursuant to Elections Code section 8168(b)(2)(A)-(D), a person shall have until 5:00 p.m. on March 16, 2022 (E-83), to file nomination documents for the following offices in the following circumstances:

- **Representative in Congress:** no person who currently holds the office of Representative in Congress delivered nomination documents for that district by 5:00 p.m. on March 11, 2022 (E- 88).
- **Member of the State Board of Equalization:** no person who currently holds the office of Member of the State Board of Equalization delivered nomination documents for that district by 5:00 p.m. on March 11, 2022 (E- 88).
- **State Senator:** no person who currently holds the office of State Senator delivered nomination documents for that district by 5:00 p.m. on March 11, 2022 (E- 88).
- **Member of the Assembly:** no person who currently holds the office of Member of the Assembly delivered nomination documents for that district by 5:00 p.m. on March 11, 2022 (E- 88).

Elections Code section 8022 is still in effect for the following offices: Governor, Lieutenant Governor, Secretary of State, Controller, Treasurer, Attorney General, Insurance Commissioner, and Superintendent of Public Instruction, such that if an

eligible incumbent for any of the offices listed in this paragraph failed to file nomination documents by 5:00 p.m. on March 11, 2022 (E- 88), any person, other than the incumbent, shall have until 5:00 p.m. on March 16, 2022 (E-83), to file nomination documents for that office.

Based on the nomination documents submitted to the Secretary of State by the county elections officials as of 6:45 p.m. on Friday, March 11, 2022, attached is the list of offices wherein the filing deadline is extended to **Wednesday, March 16, 2022**.

All nomination documents are to be forwarded by the county elections official to the Secretary of State, Elections Division, by Monday, March 21, 2022.
