Dog Dies in Yucca Valley House Fire Tuesday Night

Despite firefighter efforts to resuscitate a dog, it died during a house fire in Yucca Valley Tuesday night. Battalion Chief Bob Evans said firefighters were called to the fire in the 6200 block of Monticello Road at 10:37 p.m. and arrived on scene four minutes later. He said the blaze started in the kitchen, and aggressive efforts by firefighters contained the blaze.

The fire was knocked down in about 20 minutes.

3 Injured in Suspected Dui Crash in Yucca Valley Tuesday Morning

A suspected drunk driver is believed to be responsible for a multi-vehicle crash that sent three people to the hospital Tuesday morning. About 9:30 a.m., Thomas Vincent, 42, of Yucca Valley, was driving a 2010 Dodge Ram 2500 pick-up truck on Old Woman Springs Road in Yucca Valley when he drove into opposing lanes of traffic just south of Buena Suerte Drive and collided with a white Ford F-250 pick-up truck. A motorhome was also struck during the collision. Vincent and two occupants of the F-250 sustained serious injuries and were taken to Desert Regional Medical Center in Palm Springs. Highway 247 was closed for several hours during the investigation, and deputies say DUI is a possible factor in the crash.

Rescue Crews Unable to Save Dog That Fell into Mine

Rescue personnel from all over the county descended on the Brooklyn Mine district east of Twentynine Palms Tuesday morning in an attempt to rescue a dog that had fallen down a mine shaft. The dog's owner said he was out with his dog Sunday when the dog fell down the mine shaft.

County Fire Battalion Chief Bob Evans said Urban Search and Rescue crews who are trained in those types of rescues met the dog's owner at Highway 62 and Gold Crown Road about 8:30 a.m., and he brought them to the mine. After assessing the 300-foot mine, and the fact that the dog had been there since Sunday, rescuers determined an attempt to retrieve the dog was a lost cause.

Evans reminds residents that abandoned mine sites can pose many safety hazards and to stay away.

No injuries reported in early-morning residential fire

Firefighters responded to a structure fire in a single-story residence in the 1500 block of Lori Court early Wednesday morning. No injuries were reported.

Units arriving shortly before 3 a.m. Wednesday, Jan. 20, found no visible smoke or flames evident from outside the structure. Crews located a small fire in the attic above a bathroom.

The fire was extinguished within 15 minutes and contained primarily to the attic with extension into one bathroom. Firefighters took extra effort to limit damage to the contents of the home. Damage to the property was estimated at \$10,000 with an additional \$5,000 in content loss.

The family was able to escape the home safely prior to firefighters' arrival.

Firefighters credited early recognition by the residents and rapid response by crews for the limited damage.

In addition to 18 firefighters from Redlands, three firefighters from **San Bernardino County Fire Station 9** responded. Firefighters remained on scene for about an hour and 15 minutes.

The cause of the fire is under investigation.

2 Alarm Wind Driven Fire San Bernardino 1 19 2021

SAN BERNARDINO - At Approximately 8:42 PM on Tuesday, January 19, 2021, the **San Bernardino County Fire** along with San Bernardino PD were dispatched to reports of a Residential Structure Fire on North G Street & West 6th Street in the city of San Bernardino.

Once the first arriving engine arrived on the scene, they reported two houses on fire one being fully engulfed. The wind pushing the fire into some vegetation and causing the neighboring house to catch fire. Due to the high winds, the BC asked for second alarm response. Crews worked quickly to stop the fire from causing the second house to become fully engulfed. The cause of the fire is still under investigation.
