Woman killed, man airlifted after two-vehicle crash on Summit Valley Road in Hesperia

HESPERIA, Calif. (VVNG.com) — A woman was killed and a man was airlifted in critical condition after an early morning traffic collision in Hesperia.

It happened at about 6:13 am, on September 22, 2022, and Sumit Valley Road, just west of Trout Street. The crash involved a white 2010 Dodge Avenger and a gray 2015 Dodge Challenger.

San Bernardino County Fire responded and pronounced the female driver of the white sedan deceased at the scene. Firefighters requested a helicopter to airlift the male driver of the other vehicle to Loma Linda University Medical Center.

While officers investigated, Summit Valley Road was shut down near the Hesperia Airport at Foley Street. Neither of the involved vehicles had passengers at the time of the crash.

The Victorville CHP station is handling the investigation into the cause of the accident and additional information will be updated as it becomes available.

Nocturnal Wonderland Festival results in several arrests and two deaths over the four-day event

The San Bernardino County Sheriff's Department is contracted by Live Nation to provide law enforcement services during all shows and events at the Glen Helen Amphitheater.

During the weekend, sheriff's deputies made arrests for being drunk in public, spousal abuse, rape, petty theft and domestic battery.

The Department of Alcohol Beverage Control participated on Saturday by conducting enforcement related to minors consuming and/or in possession of alcohol, use of fake ID to obtain alcohol, etc. Eight citations were issued for minors in possession of alcohol, and one person was issued a citation for possession of a controlled substance.

In addition, onsite medical services evaluated and transported 11 people to local hospitals for further treatment. Two individuals who were transported were later pronounced dead for unknown reasons. Sheriff's investigators are conducting investigations into each of the deaths and no additional details are available for release.

In September 2016, the Board of Supervisors approved the formation of an Electronic Dance Music (EDM) Taskforce. The purpose of this group was to develop recommendations for enforceable health and safety measures required for events and all other concerts held on county property.

The Nocturnal Festival follows all recommendations and guidelines set forth by the EDM Task Force. Additionally, the EDM Taskforce was to seek input from the community, and to consider changes to future EDM events and all other concerts to address community concerns. The EDM Taskforce includes representatives from the following organizations:

Man is shot to death in San Bernardino on Sept. 20; suspect is arrested

A 46-year-old man was shot to death in San Bernardino on Sept. 20, and a suspect has been arrested in connection with the case, according to the San Bernardino Police Department.

At about 8 p.m., police received a 911 call regarding a shooting that had occurred outside a business in the 500 block of W. Marshall Boulevard. Officers responded and found Nader Alkouli, a resident of Glendale, lying on a sidewalk suffering from a gunshot wound.

The victim was treated on scene by **San Bernardino County Fire** Department personnel and was transported to a local hospital by ambulance. Alkouli did not survive his injuries and was pronounced deceased at the hospital by doctors.

During the investigation, video surveillance was obtained from the scene. William Norris, a 21-year-old San Bernardino resident, was identified as the alleged shooter and a Ramey warrant was issued for his arrest.

On Sept. 21 at about 3 p.m., Norris was taken into custody without incident at a business near University Parkway and Hallmark Parkway. He was transported to a local jail facility, where he was booked on the charge of murder.

Pedestrian Hit, Seriously Injured On Hwy 138 Onramp To Southbound I-15 Thursday Night

PHELAN, CA. (Pain In The Pass) >> A pedestrian walking on the onramp was struck by a SUV and seriously injured Thursday night on Highway 138 onramp to southbound Interstate 15, authorities said.

California Highway Patrol and **San Bernardino County Fire Department** responded to the incident of a vehicle versus a pedestrian that was reported about 7:45pm on Friday July 23, 2021. According from the CHP traffic log the pedestrian for unknown reasons was walking in the onramp to southbound I-15. Seconds later the pedestrian was hit by a red Ford Escape that did stop at the scene.

The pedestrian was transported by ambulance to Arrowhead Regional Medical Center in Colton with serious injuries, stated on the CHP traffic log. This incident will be under investigation by the California Highway Patrol Inland San Bernardino Office.
