## **Fire damages mobile home in Bloomington on April 18**

A fire damaged a double wide mobile home in Bloomington on April 18, according to the **San Bernardino County Fire** Department.

The fire was reported at a location in the 10700 block of Cedar Avenue, but firefighters responded quickly and knocked the blaze down in 15 minutes, the Fire Department said on Twitter.

No injuries were reported.

The cause of the fire was not immediately known. The incident was under investigation.

## **PLAINTIFFS NEEDED IN FEDERAL LAWSUIT AGAINST THE FP-5 FIRE TAX**

County supervisors voted April 7 to put repeal of the Fire Protection Service Zone Five, or FP-5, fire fee on the ballot this November. Now there may be more bad news for the county's cash-strapped fire administration.

Reporter Mike Lipsitz has the story...

It was a successful signature gathering effort by the non-profit Red Brennan Group that forced the repeal measure onto the ballot.

But the public advocacy group is not yet done; the Red Brennan Group remains at odds over the FP5 expansion and the protest process; now it is contemplating action in federal court.

Toward that end, the organization is in the process of identifying plaintiffs. If you own property in the 19,000-square-mile FP5 district and were unable to participate in the protest process in September 2018 because you never received a notice, weren't able to obtain a protest form, or because you lack internet, or the necessary hardware or software, the Red Brennan wants to talk to you.

## **4 airships respond to rollover crash with ejections on I-15 near Baker**

BAKER, Calif. (VVNG.com) — A single-vehicle rollover on the I-15 freeway prompted emergency personnel to request four airships to respond Monday morning.

The traffic accident was reported at 9:22 am, on April 20, 2020, along the northbound I-15, between Baker Blvd and Halloran Summit Road.

Firefighters arrived on scene and reported a single-vehicle rollover with people ejected and in the roadway.

Emergency personnel reported they had four people with life-threatening injuries and confirmed the need for all four helicopters to respond and land north of the scene.

According to the California Highway Patrol incident logs, the involved vehicle was possibly traveling on the southbound with people ejected onto the NB and SB sides of the freeway.

The incident has prompted CHP to shut down the I-15 freeway in both directions as the helicopters land.
