Hazardous waste collection site set to reopen

The Redlands household hazardous waste site at 500 Kansas St. is scheduled to be reopened from 9 a.m. to 2 p.m. on Saturday, May 30.

Beginning with this weekend's reopening, the site will be staffed by the **County of San Bernardino Fire Protection District Household Hazardous Waste Division** staff.

The Redlands Fire Department has managed and operated the collection site since it opened approximately 30 years ago. The department's Community Risk Reduction Division will continue to manage the city's household hazardous waste program.
