6) Cooperative Economic Empowerment Movement (CEEM)

The Chair, Jonathan Weldy, introduced George Lamb, President/CEO of Faith Advisory Council for Community Transformation and Kyle Webb, Chief Financial Officer of Webb Family Enterprises. Topics discussed included issues with workforce outcomes in the lower socioeconomic areas and how that leads to instability for employees, and higher sustained turnover for employers; CEEM's program offerings and how to measure their successes and success stories of some of their participants. A discussion ensued about connecting CEEM with Business Services to work with employers to train for cultural compencies.

7) Special Populations Committee Goals

Mr. Weldy led the workshop and reviewed the goals discussed at the prior meeting. He provided an update on the asset mapping, which was discussed at the previous Executive Board meeting and would like to get volunteers from the committee to define asset mapping criteria. Additional goals discussed included: Windmill training and whether to have additional sessions; storytelling and who was interested in working with the communications team; participation in the grant writing process and legislative priorities.
