1.0 Call to order

The meeting was called to order at 6:30 pm by Vice Chair Kyle Schulty

2.0 Approval of Minutes

3.0 Correspondence & Announcements by MAC members

Schulty discussed the lighting up of the arrowhead in memory of the December 2nd victims. Dinon announced that the Lake Gregory Yacht Club was collecting toys for needy families. Gill Flores discussed Shop with a Cop this Sunday.

4.0 Special Presentation

Rick Dinon presented the 5th annual Lake Gregory Improvement Committee community update. Also presenting was Tim Millington from Special Districts, and Dave Gelt, project consultant.

Items discussed including introduction of committee members present and the history of the committee. Dinon then made a presentation using a PowerPoint program that covered the main issues related to the project. There are primarily three components; dredging, valve replacement, and dam buttressing. All three were discussed in length. Dinon also discussed the storing of dredging material at the ball field location to be used later for the dam, the order to lower the lake 5 feet below the spillway, possible traffic impacts during dam construction, and removal of the restroom facility located on the dam. The total project will end up costing between \$16 to \$20 million dollars.

6.0 Community/ Agency Updates

<u>Travis Thogmartin</u> discussed Cal Fire 's defensible space program, clearing bug-killed trees in the San Moritz area, and transitional housing.

<u>Tel Preszler</u>, CHP, discusses the CHiPs for Kids toy drive. He announced that one of his officers is leaving. There were lots of traffic issues over the Thanksgiving holiday. There have been no impacts so far from the opening of Sky Park / Santa's Village.

<u>Gil Flores</u>, Twin Peaks Sheriff: Deputy Flores shared that the station has been very busy. There have been several car thefts and vehicle burglaries in the Running Springs area. He discussed some recent cases in the area including a homicide.
