4.0 Community Reports

Rim of the World Recreation & Park District: Dr. Hugh Bialecki gave an update on the Lake Gregory Recreation Center. They are holding an open house on February 21st. They will be updating all of the outdoor facilities. Will be also improving the inside; including the kitchen facilities and classrooms. Looking for ideas regarding classes and uses of the facility for the community. Will be keeping the Rimforest facility and continue to offer classes there.

CHP: Lt. Tony Coronado stated that the Mountain Office of the CHP received an enforcement grant and are increasing enforcement. They also have a commercial officer doing enforcement in the mountains. Working on an identity theft case that involves local residents.

SB County Sheriff: Capt. Gregory discussed marijuana laws. It is illegal to drive under the influence. He discussed the Sheriff's position on ICE. He encouraged members of the public to read propositions and initiatives thoroughly before voting. You can now follow Captain Gregory on Twitter. He also mentioned there have been an unusual number of auto thefts.

Cal Fire: Entering winter staffing levels. Will still have 5 stations staffed and 15 vehicles. Working on two clearing projects. Discussed bark beetle infested trees.

County Fire, Bob Evans: All County stations are fully staffed. Working with cooperators to revitalize the old MAST system. Working on several areas needing fuel reduction. Two FF training in Utah with snow cats. Some issues with phone system.

Cal Parks: Arlene Arenas discussed "Love at the Lake" event coming up at the San Moritz on Valentine's Day. Working with Cal Fire to remove bark beetle infestation. Other trees are being removed. Just stocked 2000 lbs. of fish. \$8 to fish at Lake Gregory. Discussed shoreline "blow-out" issues. Answered questions from the public.

Lake Gregory Improvement Committee Update: Rick Dinon

The Lake Gregory Improvement Committee met today. RockForce Construction was the contractor selected and approval will come before the BOS next week. They appear to be very qualified for this project. If all goes well they are eager to start ASAP.

5.0 Supervisor's Report

Lewis Murray discussed the big rig issue on Hwy 138 between Crestline and Pilot Rock. They are also looking at the intersection of Hwy 138 and Crest Forest. Cal Trans will meet with Public Works and the Crestline Chamber this month. Murray also discusses the FAA presentation made at the February Lake Arrowhead MAC meeting.
