**1.0 Call to Order**

County Fire: Ron Walls mentioned there has been a lot of activity lately. He discussed the Crestline Matterhorn incident. He discussed the I-15 bridge fire. I-15 North is now open. Fire was started by a welding accident. The Etiwanda fire is mostly contained and in a mop up situation. County Fire and other agencies had extra staff working due to high winds which paid off. He mentioned that County Fire is investigating a new GPS & wireless system to track vehicles and information.

Cal Fire: Cal Fire mentioned they will be adding a fire truck to the US Forest Service station in Skyforest.

**5.0 Supervisor's Report**

Murray reported Cal Trans notified the community at the Crest Forest MAC meeting that the delineators/channelizers will be installed on highway 18 in the next week or two. Murray discussed two board items that were approved at today's board meeting. One was related to special district fees, and the other to Prop 90.

## **6.0 Lake Gregory Update: Rick Dinon**

Dinon mentioned the committee had a meeting with the County earlier today. An engineering study was completed related to the tunnel. It was not approved. They are submitting alternatives. Related to dam, testing fill to make sure it is structurally adequate for DOSD. The dredging is still on schedule to complete balance of swim beach and the other two phases this fall. The committee is still pleased with the project management group.
