Dinon announced that the engineer in charge of the dam project has left the county and a new one, Andrew Crider, has taken over the project. Discussed potential mercury levels in Lake Gregory.

Bracher reported that he sign committee has met several times since the last meeting. The committee walked down Lake Drive to review existing signage. She expects the committee will wrap up in the next month.
