He agreed to provide a draft version of the ordinance in the next few weeks but stressed that the comments received at this evening's MAC meeting would not be addressed yet in the current draft version.

US Forest Service: Zach Behrens discussed recent Santa Ana winds. They are extending staffing through the end of the month. Discussed prescribed burning and mechanical treatments. Working on other fuel breaks.

Lake Arrowhead Communities Chamber of Commerce: Robin Bull announced the upcoming Governmental Affairs Committee meeting on the first Tuesday of each month. Working on Blue Jay parade for December 1st. She discussed other events coming up through the end of the year.

Rim Rec & Park District: Carly Corn announced they are opening a Teen Center. They are looking for sponsors and donations. Halloween event was well attended. Over 600 attendees.

Rim of the World Association of Realtors: Carol Banner shared the Realtors are Working on supporting prop 5. Opposing Prop 10.

Mountain Transit: Jesse Smith announced they have wrapped up the trolley program. Looking into extending it for next year. Looking to expand their Crestline facility.

San Bernardino County Sheriff: Lt. Don Lupear. Lt, Lupear announced that he is permanently assigned to Twin Peaks as of Saturday. This year so far there have been 1850 reports and 850 arrests. Addressing the homeless situation. Discussed possible evacuation scenarios.

CHP: Officer Carter encouraged people to call if they have parking issues. Discussed when they ticket verses when they tow. Is the officer's discretion.

Cal Trans: Murray read an update from David Matza regarding current Cal Trans projects in the Rim of the World communities.
