1.0 Call to Order: The meeting was called to order at 6:04 pm by Chair Scott Rindenow, followed by the Pledge of Allegiance.

5.0 Community & Government Updates:

- **San Bernardino County Sheriff:** Cpt. Don Lupear shared information on new deputies arriving at Twin Peaks. They recently held a coordination meeting with other first responders addressing snow play issues. They will once again be doing enforcement and writing tickets for illegal parking. Lt. Harris also discussed homeless issues in the mountain communities and what the SBSB is doing to address the issue. He also shared the protocol they use when responding to a Short Term Rental complaint.
- **CHP:** Officer Griede discussed the first responder meeting regarding winter conditions in the mountains. He thanked everyone for attending the recent open house at the CHP station in Running Springs
- **Rim of the World Recreation and Park District:** **Rim of the World Recreation and Park District:** GM Jenny Hueter introduced herself as the new General Manager. She discussed upcoming events. Most of which were Halloween related.
- **SCE:** Jennifer Cusack gave an update on Edison projects currently underway in the mountain communities.
- **San Bernardino County Fire:** Bryan James shared that it has been quiet. They continue to train and prepare for winter conditions.

- **Cal Fire:** Tony Jones said that they are starting to get a handle on the big fires in the state. He shared some statistical information.
- **Rim of the World Historical Society:** Marilyn Mayes shared that they are closing for the season on October 17th. She discussed upcoming events.
- **Mountain Rim Fire Safe Council:** Laura Dyberg discussed the grants they receive to perform specific projects in the mountain communities. The MRFSC will be expanding into Big Bear. They have received over \$1 million in grants so far this year, specifically for roadside chipping and hazardous tree removal. Laura also discussed the concern with the Gold Spotted Oak Bore beetle.
- **LACCC:** Robin Bull discussed the recent Chamber events, including the Home Tour, the Brewfest, and mixers. They are planning for the fall and winter.
- **LACSD:** Catherine Cerri reminded everyone that landscape irrigation ends on October 15th. They are very concerned with the current drought conditions. They have started drilling a new well in Blue Jay. Ms. Cerri announced that Bridgett Ortiz will be their new community liaison.
- **Senator Ochoa Bogh's office:** Sydney Sonck gave a State Legislative update, discussing several bills. He mentioned the Senator would be at the Sunrise Rotary meeting tomorrow.
- **Rim of the World Education Foundation:** Marilyn Mayes shared that they are currently holding a membership drive.
