Call to Order

The meeting was called to order at 7:02 p.m. followed by the Pledge of Allegiance

Election of Officers:

Prior to accepting nominations, Cooperman read an email he received from Scott Rindenow. The floor was opened to nominations:

- Saxbury nominated Lawrence Mainez as Chairperson, Dispenza seconded
- Cooperman nominated himself as Chairperson, Dispenza seconded

Discussion ensued regarding the proper procedure for nominations and seconds. After a lengthy discussion, both Saxbury and Cooperman withdrew their nominations.

A motion to postpone the election until April was made by Dispenza and seconded by Saxbury. Motion approved 3/1/0 with Mainez voting no.

Approval of Minutes

The minutes of the September 22, 2011 meeting were approved with no corrections. Mainez moved and Saxbury seconded to accept the minutes. Approved 3/0/1 with Dispenza abstaining.

Presentation:

Mountain Parking Ordinance: Supervisor Rutherford requested that the Lake Arrowhead MAC review the proposed Mountain Parking Ordinance and give her their feedback. A draft of the ordinance was sent to MAC members prior to the meeting. In general, the MAC members were favorable regarding the ordinance. Mainez has some concerns regarding the long term benefits of the ordinance, and questioned if it was just a band-aid and not addressing a bigger issue.

ACTION ITEMS:

Cooperman made a motion to support the Mountain Parking Ordinance and to state that we believe this is part of an evolutionary process to address this and other issues that are negatively impacting the businesses community. Saxbury Seconded.

Approved 4/0

Meeting Dates and Times for Future MAC Meetings

Lewis Murray requested that the MAC set up a regular meeting date so that members of the public and press will know when the MAC will meet. His only request is that it not be the 4th Thursday since the Crest Forest MAC has been meeting on that date for many years.

After discussing multiple dates, Cooperman made a motion that the Lake Arrowhead MAC schedule meetings for the first Monday of each month at 7:00 pm. Meetings will not be held if there are no agenda items to be discussed. Mainez seconded the motion.
