1.0 Call to Order & Pledge of Allegiance

Chair Voni Saxbury called the meeting to order at 6:04 p.m. followed by the Pledge of Allegiance.

5.0 Community & Government Updates

Scott Rindenow: Rindenow introduced the airplane route issue. Dakota Higgins from Congressman Cook's office, Lewis Murray from Supervisor Rutherford's Office, Daniel Adamus, Chief of Marketing at Ontario Airport, and David Caine, citizen, shared information with the attendees. Many residents shared their experiences and concerns.

Ambrozic made a motion to support a Change.org website to collect signatures of support. Rindenow seconded. Approved 5/0/0

ALA: Roberta Rindenow gave an update on lake level, events, and other activities at the lake. There is major construction going on at the Water District intake. GM Jim Grant will be retiring soon. ALA is looking for an associate GM to eventually replace Jim Grant.

SB County Fire: Larry LaVogue discussed a defensible space checklist. He also distributed a flier for the chipping program.

Cal Fire: Mark Barr discussed that Cal Fire just completed their fire preparedness exercise in Cedar Glen. They are currently at peak staffing. They will be starting defensible space inspections in a week or two.

LACCC: Robin Bull shared that the Chamber is seeing an increase in tourists. There are lots of events scheduled for this summer. She discussed their new office and invited everyone to stop by.

Rim Rec: Bob Kinzel discussed recreation activities on the mountain this summer. Rim Rec is making progress on their ATP grant process. Park district is negotiating on two school district sites for new parks. Bob discussed the Run through the Pines 5k scheduled for this August. They are hoping for 600 runners.

Senator Morrell's Office: Shane Massoud shared that the legislature has been active. SB 562 Single payer health care is in the Senate. The cost would be \$250 to \$400 billion. The bill raises payroll taxes. He also discussed several other bills that raise taxes. The Senator had several bills submitted but not passed.

Congressman Cook's Office: Dakota shared that Congressman Cook voted for the repeal of the Affordable Care Act. He voted for the budget. He is also supportive of the Hire Vets act.

CHP: Discussed their new Senior Volunteer Program. They currently have 15 volunteers in the program. The program is similar to Citizens on Patrol.

Sheriff: Capt. Gregory announced that Twin Peaks Station is fully staffed. He discussed the arrest of a felon making threatening calls and claiming to create an Arrowhead massacre in the Village. The Sheriff's office deployed additional forces in the Village. The department began its Marine Enforcement Program this past weekend. Biggest issue is ALA using blue lights on their boats. He shared some stats from this past weekend.

Tudor House: John Conner gave an update on events at the Tudor House.

Rim of the World Association of Realtors: Carol Banner discussed new MLS system. Discussed market conditions.

6.0 Supervisor's Report: Murray discussed the short-term rental ordinance and the 24/7 hotline. He invited everyone to the Crest Forest MAC meeting on June 6, 2017. He also discussed the status of the Lake Gregory Dredging and the Sky Park project.
