The San Bernardino County Local Enforcement Agency (LEA), will be holding this public information meeting for any interested parties to learn more about the proposed Solid Waste Facility Permit (SWFP) Revision for Rialto Bioenergy Facility and to provide comments to the LEA regarding the proposed action. The LEA is certified by the Department of Resources Recycling and Recovery (CalRecycle) to enforce state laws and regulations at solid waste sites within the County of San Bernardino, including all transfer/processing and in-vessel digestion facilities. All comments received at this public meeting will be accepted by the LEA and forwarded to CalRecycle for their consideration of concurrence to revise the Solid Waste Facility Permit for Rialto Bioenergy Facility. All comments will be considered when the LEA makes a determination to process the proposed permit. CalRecycle will act on the LEA's recommendation for a revised SWFP within the next 90 days.

## The proposed SWFP Revision for Rialto Bioenergy Facility involves the following changes:

- The modification of the existing, non-operational biosolids processing facility into an organic waste processing facility. The revised permit will allow for the acceptance of up to 1,080 tons per day of a combination of commercial food waste, liquid waste and municipal biosolids.
  - Food and liquid wastes will be processed on site, via anaerobic digesters, to generate renewable energy.

## LEA's preliminary determination:

The permit revision application was accepted as complete and correct on July 31, 2020. A proposed revised permit will be sent to CalRecycle requesting concurrence and subsequent LEA issuance.
