The San Bernardino County Department of Public Health, Division of Environmental Health Services, Local Enforcement Agency (LEA), will conduct a public information meeting for any interested parties to learn more about the proposed **Solid Waste Facility Permit Revision for the Victorville Sanitary Landfill SWIS No. 36-AA-0045**. Due to current COVID-19 concerns the meeting will be held **virtually via zoom**. Interested parties may provide comments to the LEA regarding the proposed actions. The LEA is certified by the Department of Resources Recycling and Recovery (CalRecycle) to enforce state laws and regulations at solid waste sites within the County of San Bernardino, including all disposal site facilities. All comments received at this public meeting will be accepted by the LEA and forwarded to CalRecycle for their consideration of concurrence to revise the Solid Waste Facility Permit for the Victorville Sanitary Landfill. All comments will be considered when the LEA makes a determination to process the proposed permit. CalRecycle will act on the LEA's recommendation for a revised SWFP within the next 90 days.

Description of Project:

The Victorville Sanitary Landfill, Facility No. 36-AA-0045 is located in San Bernardino County (County) in the High Desert Region of the Victor Valley. The Victorville Sanitary Landfill is designed to provide landfill services to High Desert Region of the Victor Valley area. The landfill originally began as a burn site in 1955 and converted to solid waste sanitary landfill in 1975. The SWFP issued in 1998 allowed a landfill capacity of 7.7 million cubic yards (mcy). In 2004, the owner proposed an expansion to the landfill with additional capacity of 85.7 mcy and obtained necessary regulatory approvals. The total landfill capacity including the expansion will be 93.4 mcy. However, the current SWFP shows the permitted design capacity as 83.2 mcy. An application for permit

revision was received by the LEA from San Bernardino County, Solid Waste Management Division on July 1, 2020 to correct the site capacity error in the current permit.

The proposed SWFP Revision for the Victorville Sanitary Landfill involves the following changes:

- **Correction** of the Permitted Site Capacity for the landfill to show the full CEQA approved permitted site capacity of 93.4 million cubic yards (mcy) reflecting the approved capacity of 85.7 mcy described in the CEQA documents prepared in 2004 for the landfill expansion project, plus the approved pre-expansion site capacity of 7.7 mcy. This SWFP Revision is only to update the SWFP to be consistent with CEQA.

LEA's Preliminary Determination:

The permit revision application was accepted as complete and correct on July 31, 2020. A proposed revised permit will be sent to the California Department of Resources Recycling and Recovery (CalRecycle) requesting concurrence and subsequent LEA issuance.

Purpose of the Meeting:

This Public Informational Meeting is for any interested parties to learn more about the proposed permit and to provide comments to the LEA regarding the proposed action. The decision to issue or not to issue the SWFP (revision, modified, new) must be made by the LEA within 120 days of the date the application was deemed complete as required by Statute. Prior to issuance of the SWFP, the LEA must request and receive concurrence from the CalRecycle
