Please be advised that the County of San Bernardino, Department of Public Health, and Division of Environmental Health Local Enforcement Agency (LEA) received and accepted a Report of Facility Information (RFI) amendment to the Joint Technical Document (JTD) for the Landers Sanitary Landfill. The LEA is certified by the California Department of Resources, Recycling and Recovery (CalRecycle) to enforce state laws and regulations at solid waste sites within the County of San Bernardino, including all active and closed landfills.

## Description of Project and LEA's Preliminary Determination

Landers Sanitary Landfill is located at 59200 Winters Road in Landers, California. On June 19, 2020, the LEA received, from Landers Sanitary Landfill, a Solid Waste Facility Permit (SWFP) application package to amend their JTD in the form of an RFI amendment.

The changes include the following:

- Updates to the operational changes related to the use of processed green material as ADC, handling and processing of green waste materials, and chipping and grinding activities at the site.
- Addition of a Notice of Exemption for Final Grading Plan Adjustments (2018)
- Update to Volume III-B's Table of Contents

The LEA finds that the proposed change is consistent with all applicable certified and/or adopted CEQA documents, is consistent with State Minimum Standards, and does not conflict with the terms and conditions in the current solid waste facilities permit. The LEA accepted the amendment on July 22, 2020
