All comments will be considered when the LEA makes a determination to process the proposed permit. CalRecycle will act on the LEA's recommendation for a revised SWFP within the next 90 days.

Description of Project and LEA's Preliminary Determination

The LEA, will be holding this public information meeting for any interested parties to learn more about the proposed **Solid Waste Facility Permit (SWFP) Revision** for the **Victor Valley MRF & Transfer Station (VVMRF)** Expansion Project and to provide comments to the LEA regarding the proposed action.

The proposed SWFP Revision for the VVMRF Expansion Project involves the following changes:

- Increase total acreage from 13.7 to 18.57
- Increase total maximum daily tonnage from 500 to 1,235 tons per day
- Revise hours of operation
- Addition of food waste and CDI wastes as acceptable materials
- Add a 100 tpd aerated static pile compost facility
- Add an 8,000 sf food waste receiving building
- · Add an approximately 3.6-acre organics processing area

- Construct a new entrance at the southwest corner of the project
- Add a new scale house to the new entrance driveway
- Construct new driveway at northeast corner of the project
- Install two storm water detention basins
- Add a 16,000 CDI sorting facility

- Add compost rolling stock
- Increase tire storage volume
- · Add CDI sorting building and equipment
