Please be advised that the San Bernardino County, Local Enforcement Agency (LEA) received and approved a Report of Facility Information (RFI) amendment for Big Bear Refuse Disposal. The LEA is delegated by the California Department of Resources Recycling and Recovery (CalRecycle), to enforce state laws and regulations at solid waste sites within the San Bernardino County, including all active and closed landfills.

# Description of Project and LEA's Preliminary Determination

Big Bear Refuse Disposal is located at 38550 Holcomb Valley Road, Big Bear City, CA 92314. On July 20, 2023, the LEA received a Solid Waste Facility Permit (SWFP) application package for Big Bear Refuse Disposal to amend the RFI to update information in the current RFI based on "Findings" identified during the site's 5-Year Permit Review. The amendment includes updates to the Post Closure Maintenance Plan (PCMP) including corrected site disposal acreage based on the current site monitoring documents and review of final closure plans and CEQA documents.

The LEA finds the proposed change to be consistent with all applicable certified and/or adopted CEQA documents, is consistent with State Minimum Standards, and does not conflict with the terms and conditions of the current solid waste facility permit (SWFP). The LEA has reissued the SWFP indicating the corrected site disposal acreage. The LEA accepted the RFI amendment on August 18, 2023.
