Purpose of the Meeting

As a property owner, tenant or person who has requested notice, please be advised that the San Bernardino County, Department of Public Health, Division of Environmental Health Services Local Enforcement Agency (LEA) will be holding a joint meeting with the Applicant of Cemex Black Mountain Quarry Plant, Solid Waste Information System (SWIS) # 36-AA-0506, for the public or interested parties regarding the proposed new Solid Waste Facility Permit for Kiln 2 - EMSW Conversion Facility. The joint meeting is for an informational meeting by the LEA to provide information pursuant to California Code of Regulations (CCR) Title 27 Section 21660.2 and a public meeting by the Applicant to address public comments pursuant to 27 CCR § 21570(g). The informational meeting is also used to incorporate comments from the public or interested parties for the purposes of consideration when drafting the proposed Solid Waste Facility Permit (SWFP) for the Facility. The comments may also be used in consideration of the Facility.

The LEA will make a determination regarding the proposed SWFP and must be made by the LEA within 120 days of the date the application was deemed complete as required by Statute. Prior to issuance of the SWFP, the LEA must request and receive concurrence from CalRecycle.

The LEA is certified by CalRecycle to enforce state laws and regulations at solid waste sites within San Bernardino County.

Description of Project

The Facility is located at 25220 Black Mountain Quarry Road, Apple Valley, CA 92307. The Conversion Facility is located in a remote area northeast of the City of Victorville and the town of Apple Valley, in an unincorporated area of San Bernardino County. There are no structures or industrial uses within one mile of the facility.

On February 15, 2024, the LEA received, from the Applicant, an application for a Solid Waste Facility Permit for Kiln 2- EMSW Conversion Facility in a CalRecycle E-1-77 Form (rev. 11/15).

The Facility intends to replace the use fossil fuels with 500 tons per day of engineered municipal solid waste (EMSW) for Kiln 2.

The proposed permit allows the Facility the following design and operation:

- Operate an Engineered Municipal Solid Waste (EMSW) Conversion Facility
- Receive up to 500 tons per day of EMSW for use as fuel to run Kiln 2
- Allow up to 20 vehicle trips per day for EMSW
- Operate during the following hours for operations, maintenance, processing and receipt and transfer of materials:

Monday-Sunday (24 hours per day)

- Activities at the Cemex Black Mountain Quarry Plant will include material receiving (each EMSW delivery will be accompanied with a shipping paper indicating the load is of non-hazardous conformance), load checking, and monitoring and testing.
- Obtain quarterly "grab" sampling to be sent to the California Certified Lab for hazardous materials quantification.

• Should a sample be determined hazardous, Cemex will conduct a thorough investigation, including that of the supplier.

State law requires compliance with the California Environmental Quality Act (CEQA) either through the preparation, circulation and adoption/certification of an environmental document and mitigation reporting or monitoring program or by determining that the proposal is categorically or statutorily exempt.

- An Initial Study was conducted on November 24, 2020 resulting in no new significant environmental effects for Cemex State Clearinghouse No. (SCH # 2020110438) was circulated for a 30-day review period from November 24, 2020 to December 24, 2020. The Final MND package was certified by the County of San Bernardino Department of Public Works.
- The documents above support the limits of the proposed permit as follows:
 - o Operating Hours: 7 Days per week, 24 hours per day.
 - o Permitted Tons Per Operating Day: 500 tons per day.
 - o Permitted Traffic Volume: 20 vehicles per day.

The LEA finds that the proposed SWFP is consistent with and is supported by the environmental documents cited above, and information contained in the Facility's Report of Composting Site Information.
