## Purpose of the Meeting

As a property owner, tenant or person who has requested notice, please be advised that the San Bernardino County, Department of Public Health, Division of Environmental Health Services – Local Enforcement Agency (LEA) will be holding a joint meeting with the Applicant of One Stop Landscape Supply Center Composting Facility (Facility), Solid Waste Information System (SWIS) # 36-AA-0308, to the public or interested parties regarding the proposed composting activities at the Facility. The joint meeting is for an informational meeting by the LEA to provide information pursuant to California Code of Regulations (CCR) Title 27 Section 21660.2 and a public meeting by the Applicant to address public comments pursuant to 27 CCR § 21570(g). The informational meeting is also used to incorporate comments from the public or interested parties for the purposes of consideration when drafting the proposed Solid Waste Facility. The LEA will make a determination regarding the proposed SWFP and must be made by the LEA within 120 days of the date the application was deemed complete as required by Statute. Prior to issuance of the SWFP, the LEA must request and receive concurrence from CalRecycle.

The LEA is certified by CalRecycle to enforce state laws and regulations at solid waste sites within San Bernardino County, including all composting facilities.

## **Description of Project**

The Facility is located at 13024 San Timoteo Canyon Road, Redlands, CA 92373 within the incorporated portion of San Bernardino. The Facility is located on the Northwest 20-acre portion of a 160-acre parcel owned by the operator, Curti Family Trust. On May 31, 2023, the LEA received, from the Applicant, an incomplete application package for a Compostable Materials Handling Facility (CMHF) Permit in a CalRecycle E-1-77 Form (rev. 11/15). The complete application package was received after the City of Redlands Resolution 8519 was approved on October 17, 2023. The LEA determined the application package to be complete and correct pursuant to Title 27 California Code of Regulations (CCR) §21570 and §21650 on November 2, 2023. The Facility is an existing large volume compostable material handling facility. The revision to the permit is intended to include food materials as an approved feedstock to allow the facility to receive and compost food materials in addition to the already approved feedstocks per the CMHF permit. The wastes arriving on site are primarily generated within the Santa Ana Regional Water Quality Control Boundaries.

The proposed permit revision allows the Facility the following design and operation:

• Receive and process food waste for composting.

State law requires compliance with the California Environmental Quality Act (CEQA) either through the preparation, circulation and adoption/certification of an environmental document and mitigation reporting or monitoring program or by determining that the proposal is categorically or statutorily exempt. The City of Redlands, acting as Lead Agency, made a determination and Notice of Exemption for CEQA for One Stop Landscape Supply Center Composting Facility located in Redlands. Resolution 8510 was approved by Redlands City Council on October 17, 2023. The categorial exemption, Class 1 Existing Facilities, Section 15301, was posted on October 18, 2023.

The documents above support the limits of the permit as follows:

- Permitted feedstocks: Agricultural, construction/demolition, wood mill waste, food waste, sewage sludge (No more than 250 TPD of sewage sludge may be accepted without first obtaining a revised permit)
- Operating Hours: Monday through Saturday 7:00 AM- 5:00 PM.
- Permitted Tons Per Operating Day: 500 tons per operational day.
- Permitted Traffic Volume: A maximum of 10 vehicles of sewage sludge per operational day.

The LEA finds that the proposed SWFP revision is consistent with and is supported by the environmental documents cited above, and information contained in the Facility's Report of Composting Site Information.
