Purpose of the Meeting

As a property owner, tenant or person who has requested notice, please be advised that the San Bernardino County, Department of Public Health, Division of Environmental Health Services – Local Enforcement Agency (LEA) will be holding a joint meeting with the Applicant of Victor Valley Materials Recovery Facility and Transfer Station (Facility), Solid Waste Information System (SWIS) # 36-AA-0346, for the public or interested parties regarding the proposed Solid Waste Facility Permit (SWFP) Revision. The joint meeting is an informational meeting by the LEA to provide information pursuant to California Code of Regulations (CCR) Title 27 Section 21660.2 and a public meeting by the Applicant to address public comments pursuant to 27 CCR § 21570(g). The informational meeting is also used to incorporate comments from the public or interested parties for the purposes of consideration when drafting the proposed revised SWFP for the Facility. The LEA will make a determination regarding the proposed revised SWFP within 120 days of the date the application was deemed complete and correct as required by Statute. Prior to issuance of the SWFP, the LEA must request and receive concurrence from CalRecycle.

The LEA is certified by CalRecycle to enforce state laws and regulations at solid waste sites within San Bernardino County, including all transfer/processing facilities.

Description of Project

The Facility is located at 17000 Abbey Lane, Victorville, CA 92394. On March 4, 2024, the LEA received, from the Applicant, an application package for a Solid Waste Facility Permit (SWFP) Revision.

The requested Revision is to increase the daily quantity of compostable organics from 100 tons per day (tpd) to 200 tpd, with no change to the maximum permitted daily tonnage of 1,235 tpd. The permitted daily tonnages will be adjusted as follows:

- Commingled Recyclables 500 tpd
- Compost and Organics 200 tpd
- CDI Sorting 150 tpd
- Mixed Waste Processing 385 tpd

A Mitigated Negative Declaration (MND) was certified by the City of Victorville on December 9, 2015. This document was released for a 30-day public review under State Clearinghouse SCH No. 2015191108. An addendum to this original MND was approved as part of the 2023 Minor Conditional Use Permit (CUP) approval for this project by the City of Victorville Planning Commission on December 8, 2023. The LEA finds that the proposed SWFP Revision is consistent with and is supported by these environmental documents, and information contained in the Facility's Transfer Processing Report.
