Approve Minutes of March 19, 2012</p>	<p>Recommended revision to Item 5: Of the original FY 2012/2013 budget, Allan Rawland suggested that each department reduce their budget to proportional share.</p> <p>Action: Motioned by District Attorney Ramos and seconded by Linda Haugan to approve minutes as revised.</p>																
<p>3. FY 2012/2013</p>	<p>Review of revised AB109 funding requests (handout).</p>																

<p>Budget Review</p>	<p>Workforce Development Department's funding request corrected from \$64,522 to \$195,000; \$65,000 each for 3 Workforce Development Specialists assigned to each Day Reporting Center (DRC).</p> <p>Chair Scray advised committee the need to approve budget but with the understanding this is potential money. Unknown when state budget will be approved, but funds can be redistributed when state budget is known.</p> <p><u>Actions:</u></p> <ol style="list-style-type: none"> a. Motioned by DA Ramos and seconded by Linda Haugan to approve budget allocations which includes \$195,000 for Workforce Development Dept. b. Motioned by Mike Ramos (replaced Gerry Newcombe) and seconded by Linda Haugan for remaining balance be referenced as "Unallocated Reserve".
<p>4. Roundtable</p>	<ul style="list-style-type: none"> • DA Ramos – ACLU article comparing numbers from counties; DA will share copy of article. • Chief Scray – Department deployed six Probation Officers (POs) to law enforcement agencies last week; six additional POs will be deployed on April 26 and 6 more in May. <p>Rancho DRC is targeted to open before July 1. Rancho will be pilot office, and an official notice will be sent when DRC opens.</p> <p>San Bernardino DRC will be functioning before July 1. If building is not ready, services will be available at a temporary location.</p> <p>Victorville City Council meeting tonight to vote on whether to grant a building permit for DRC. If city denies, Probation has contingency plan to move juvenile services into another building and use the current building as a DRC and Adult Services.</p> <p>PO has been assigned to Fontana Drug Court. San Bernardino might receive another PO. 31 POs starting in Core academy class next week.</p> <p>Treatment services for Barstow, Joshua Tree, Needles, and mountain areas will have to be contracted out.</p> <ul style="list-style-type: none"> • Dept. of Behavior Health – AB 1913 (Skinner) under review. Bill would allow a person on post release supervision, with a revocation petition, to file a bail application with Superior Court. County agency would be

	<p>responsible to notify District Attorney. Concern is that AB 1913 would impose additional duties on local agency. Supported by Bail Bond Coalition & Public Defender Assoc. Opposed by Probation Officers of Calif. and Calif. Probation, Parole & Correction Assoc.</p> <p>AB 2031 (Fuentes) would add a rank-and- file deputy sheriff and probation officer to membership of a Community Corrections Partnership and would require their votes on local plans. Supported by State Coalition of Law Enforcement Assoc. and Coalition of Probation Organizations (line level staff). Opposed by Calif. Chief Probation Officers and State Sheriff's Assoc.</p> <ul style="list-style-type: none"> • Sheriff's Office - Discussion on a bill (# unknown) which allows treatment services to count as custody time. Questioned raised on which agency would pay for treatment. Individuals responsible to show they are productive and participating in services. <p>Action: Undersheriff Fonzi will research and provide overview of this bill.</p>
