2. Approve Minutes of April 3, 2012	<p>Review of minutes.</p> <p>Action: Motioned by Sheriff Hoops and seconded by Chief Jones to approve minutes as written.</p>																
3. AB 109 Formula Allocations	<p>Allocations for FY 2012/2013 decreased budget by 9.28% due to new funding formula; reduction of \$6,408,929 on what was anticipated.</p> <p>Linda Haugan submitted revised budget for Department of Behavioral Health (DBH). DBH will absorb the reductions for the Human Services departments (Public Health, Children & Family Services, Dept. of Aging & Adult Services and Transitional Assistance Dept.).</p>																

	<p>Chief Scray proposed revised AB 109 allocations as follows (handout on file):</p> <p>Probation – \$23,862,404 Sheriff – \$25,141,920 District Attorney – \$1,429,001 Public Defender – \$1,010,566 Dept. of Behavioral Health – \$3,818,121 Workforce Development Dept. – \$176,904 Human Resources – \$114,678</p> <p>The Unallocated Reserve of \$693,666 was lost due to reduction.</p> <p>Action: Motioned by Chief Scray and seconded by Sheriff Hoops to approve revised budget allocations for FY 2012/2013; unanimously approved.</p>
<p>4. Roundtable</p>	<ul style="list-style-type: none"> • <u>Sheriff & Undersheriff</u>– Alternative sentencing bill (# unknown) would allow treatment services to count as custody time. Department would have discretion on developing criteria. Still unknown on how county would be impacted. Credit would be given for time spent in training. Some individuals sentenced could have transportation issue. Unknown on how transportation would be paid for these individuals. There are many unknown issues regarding this bill. <p>Approximately 1000 individuals have been released early so far.</p> <p>Action: Sheriff’s Office will research and provide overview of the bill.</p> <ul style="list-style-type: none"> • <u>District Attorney</u> - Restitution victims’ bill might pass. Hearing complaints from staff that Day Reporting Center (DRC) services are still not available. • <u>Gary McBride</u> – The CAO Realignment Allocation Committee recommended a two-year formula for FY 2012/2013 and 2013/2014; believe formula will carry over to next year. <p>Chief Scray commented that allocation would be an additional 11 million, enough to restore the cut taken this year.</p> <ul style="list-style-type: none"> • <u>Chief Scray</u> – As of May 17, received 2754 cases, 977 more than what CDCR projected; 30% are high risk. 523 offenders arrested on new charges (misdemeanor and felony; no convictions as unable to track). 589 have been returned to custody by Probation.

	<p>Most police departments (PDs) have their assigned Probation Officer (PO) and feedback is good. High risks were identified correctly, and PDs making numerous arrests. Law enforcement is another component in addition to treatment. Needles and small areas still need assigned POs; about 6 to be filled by end of this month.</p> <p>CORE Academy class has started and another class will start next month.</p> <p>All DRCs will be open June 1 to provide services. San Bernardino DRC will be temporarily on Mt. View. High Desert will operate in the Victorville office, and the juvenile services will be moved to a new building. This building is leased and is in the right zone; therefore, don't anticipate problems with city. Waiting on partnering departments to assign their staff to provide services. West End will be clinic and will have more staffing. All positions should be filled by end of this year.</p> <p>RFP for homeless housing is out.</p> <p>No requirements for Executive Committee to meet regularly. Committee will meet again in August or September.</p>
