Dear Continuum of Care Bonus Applicant:

We regret to inform you the Interagency Council on Homelessness will not be recommending your project, SB HOPE Campus, to the U.S. Department of Housing and Urban Development (HUD) in response to the Request for Proposals for Fiscal Year 2023 Continuum of Care Bonus Project funds in the amount of \$1,148,352.

On Wednesday, August 15, 2023, the Grant Review Committee was not able to rank or score your application as the project component, "Support Services Only - Coordinated Entry System", did not match the project description activities as noted in the project application. Further clarification provided by agency staff confirmed they were requesting "Support Services Only" funding, not "Support Services Only - Coordinated Entry System". "Support Services Only" alone is not an eligible project component for Continuum of Care Bonus Project funds.
