Mr. Darbee provided a presentation that explained what regional access points are, the goals and objectives, the funding breakdown by regions, and the application process for the RFA for local CES regional entry points. The Vice-Chair opened the floor to the Committee members for comments/questions. Astrid Johnson-Stated that when applying it does not work when using a phone to apply and if an error is made, the system will highlight it in red. Mrs. Johnson stated that after hitting the submit button an 		

		 William Lamas- Asked if Inland SoCal United Way & 211+ is providing technical assistance to the regional access points. Christopher Darbee- Stated they will be providing technical assistance and it is a partnership and group effort to make the system work. Astrid Johnson- Asked if there will be any trainings conducted prior to the start of the program. Christopher Darbee- Stated there will be a few trainings which Aziza will provide, and some will be from BitFocus on the technical piece that will be built out on how to utilize it within the new system in January or February. Kameron Grosvenor- Asked at what point does Christopher Darbee see the regional access points be the point of contact in the community. Christopher Darbee- Stated 211 is still available as an access point through then. Mr. Darbee stated that it would start almost immediately once the workflows are built out from a technology standpoint. Mr. Darbee informed that the system's going to be built around those regional access points and how that technology is going to fit the need of the community. William Lamas- Asked if the application closes on August 21st and the decision from Inland SoCal United Way & 211+ is made in September does this have to be brought to ICH for approval or is it just their decisions. Christopher Darbee- Stated CESH was already approved so it is going to be their decision upon insight and discussions within the regional access points. Mr. Darbee stated they are going to be working in conjunction with those within the region ald base the decision upon insight and discussions within the regional access points. Mr. Darbee those decisions fast because it is a very short timeline to really get this money expended. Darryl Evey- Asked if there are other regions that are doing something similar to regional access to their coordinated entry. Christopher Darbee- Stated that Los Angeles has something s
Coordinated Outreach Referral, Engagement (C.O.R.E.) Program	Deputy Mike Jones, Sheriff's H.O.P.E Team	The Vice-Chair recognized Deputy Mike Jones on behalf of the Sheriff's H.O.P.E Team to present on the Coordinated Outreach Referral, Engagement (C.O.R.E.) Program.
		Deputy Jones provided a presentation that explained the coordinated outreach efforts throughout San Bernardino County, the C.O.R.E. program, the recommended core elements of street outreach, systematic coordination of outreach, and county-wide outreach working in tandem.
		 The Vice-Chair opened the floor to the Committee members for comments/questions: Darryl Evey: Stated a concern that he has heard that was brought up was sharing the information about where people are and law enforcement using that information as an opportunity to find the person and

		 arrest them. Deputy Jones- Stated they've done all their mapping since 2017 and only three arrests were made because they had a gun on them or were sleep with a gun on them. Deputy Jones informed that the only access is actually the people that are on their team and don't use it to search for suspects. Deputy Jones informed that with information sharing through Aziza hub would be through the outreach groups. Deputy Jones informed that it was instrumental in the governor's room key that had a specific population of sixty-five and older where they were able to pull those maps and go to that population. Deputy Jones informed that the mapping is to target services to that person and not used for any criminal activity. Deputy Jones informed
		 that access is very limited so that there is no distrust in the community. Darryl Evey- Asked what about people who are undocumented. Deputy Jones- Stated that over the twenty thousand contacts that he has talked to less than ten have been undocumented, so it is rare but just like CES or homeless providers they are served the same way as anybody else. Deputy Jones stated the survey doesn't ask any criminal activity or documentation questions. Darryl Evey- Stated that he works with a let of people who are undocumented, and it is common issue that
		 Darryl Evey- Stated that he works with a lot of people who are undocumented, and it is common issue that comes up that they don't want to be a part of CES because they're worried about how it is going to affect them. Mr. Evey asked Deputy Jones what his recommendation is moving forward. Deputy Jones- Recommended having the ICH board make a recommendation to move forward with a CORE approach where the providers would more likely take a collaborative approach. Darryl Evey- Stated it would be important if there was a street outreach collaborative ad hoc committee it would be most effective if it included people that are doing street outreach and not the supervisors. Mr. Evey stated that asking people who are doing outreach regardless of whether they're receiving county funding or ICH funding come together to coordinate because it would be valuable to open the committee to everybody instead of just CoC member.
		 Deputy Jones- Suggested having a two-level regional type of approach. Deputy Jones stated that a lot of outreach groups may not know who is doing what and where so providing a tool to give a resource would be helpful. Kameron Grosvenor- Asked about where in the process are they with this considering the deadlines are going until 2025. Deputy Jones- Stated that the funding that is allocated for this has already been approved by the board to spend on technology. Deputy Jones stated that the county has a GIS team they do things through so they will be able to build out and try to figure out a way to utilize that type of contact and technology. Astrid Johnson- stated they applied to be a IEHP provider for services and are waiting for that contract to
