It is our pleasure to inform you that on Thursday, August 11, 2016, the County of San Bernardino Interagency Council on Homelessness (ICH) Grant Review Committee (GRC) voted to recommend the Rapid Re-Housing program: KEYS for Success in the amount of \$283,480 to ICH for inclusion in the Fiscal Year (FY) 2016 Housing and Urban Development (HUD) Continuum of Care (CoC) Program submission to HUD.
