## RENTER DETAILS

- A household earning \$8/hour at 40 hours/week can afford to spend as much as \$416 per month in rent.
- A renter household needs to earn at least \$18.44 per hour in order for a two-bedroom rental unit at the Fair Market Rent to be affordable.
- An individual whose sole source of income is SSI can afford to spend as much as \$202 in monthly rent.
