The OHS Facilitator's role is to manage the integrity of the evaluation process. The OHS Facilitator is not a voting member.

INDIVIDUAL EVALUATIONS

- Regional evaluation panels are established and comprised of members of each Regional Steering Committee. These panel members will review all regional specific Applications and participate in the evaluation process.
- Immediately following this meeting, Evaluators will begin independently reviewing and scoring the Applications. They will be given a link to all necessary documents, including the regional applications.
- Individual evaluations must be completed one week prior to your regional steering committee
 meeting, and prior to the region-by-region evaluator discussion meeting.

Regional Steering Committee - Region-By-Region Discussion

- The OHS Facilitator will host a region-by-region evaluator discussion meeting so that Evaluators within that region can discuss their individual scores. They can ask and resolve questions; however, this is **not** for the evaluators to agree upon scoring. At the end of this discussion, each evaluator will be given an option to revise their scores.
- Evaluators MUST make INDEPENDENT determinations for scores, including review and understanding of any additional information obtained within the group discussion. If a score is revised, the Evaluator will strike out the original score, document the new score, and provide comments to support the revision.
- If clarifying information is needed at any point, the Facilitator will contact Applicant(s) to obtain the necessary information. The Facilitator will then provide the information to the evaluation panel electronically or verbally, as appropriate.
- Once ratings are finalized and documented, the Facilitator will collect all individual evaluation worksheets
 to compile final regional scores in anticipation for recommendation and presentation to ICH.

Evaluator Rules and Guidelines

- Evaluators are instructed not to discuss any part of the Applications outside of the committee.

Evaluation Process

- Each Evaluator will independently evaluate each Application in relation to the Evaluation Criteria and their professional expertise. Each application shall be rated solely on the information contained within each Application - do NOT assume something that is not contained in the Application.
- Evaluators need to write comments to justify the overall score for each category.
- OHS Facilitator will proctor a region-by-region evaluator's discussion. Individual Scoring Rubrics MUST be completed
 before this meeting. This meeting is a post evaluation review that allows for evaluators to openly discuss how and why
 they scored the applicant as they did. It will also allow for any final changes and/or comments, on their evaluation sheets.
- OHS Facilitator will collect individual Scoring Rubrics and calculate final scores.
- By the end of this meeting, Regions should be ready to make their final decision for Regional Steering Committee recommendation and adoption.

Timelines for Evaluations and Meetings

May 23, 2023 – June 1, 2023:

- Individual Evaluations completed by RSC evaluators
- Region-by-Region Evaluation Discussions are to be determined. They will need to take place prior to each Regional Steering Committee meeting:

 - Desert: Tuesday, June 6, from 2-3:30 p.m.
 - Youth Advisory Board: Wednesday, June 7, from 5-7:30 p.m.
 - Central Valley: Wednesday, June 7, from 1-3 p.m.
 - Mountain: Monday, June 12, from 1:30-3 p.m.
 - West Valley: Wednesday, June 14, from 9-11 a.m.
