Central Region Agency Response	Jessica Alexander, Operation Grace	<ul style="list-style-type: none"> • Operation Grace offers food, shelter, bridge housing, emergency shelter, and permanent affordable housing programs to people in San Bernardino County • The Central Region Provider Network has 14 entities who participate in their Steering Committee meetings – 7 government and 7 non-government members – 4 cities participate, Colton, Rialto, San Bernardino, and Redlands • The Central Region has a larger number of individuals experiencing homelessness than the mountain regions • Their goal is to bring government and non-government entities together to resolve issues surrounding homelessness in the Central Region • It is important to gather information from people who ask for help in order to direct them to the proper organization • There is room for improvement on providing more funding to CES providers • There is a special ICH meeting this Wednesday, August 10, 2022 on CES
