In September 2007, the San Bernardino County Homeless Partnership (SBCHP) was formed to provide a more focused approach to our goal of ending homelessness within the County. The Partnership consists of city governments, community based organizations, faith-based organizations, educational institutes, non-profit organizations, private industry, and federal, state, and local government.

SBCHP was developed to promote a strong collaboration between agencies to direct the planning, development, and implementation of the County's 10-year-plan to end chronic homelessness. The Partnership meets on the third Wednesday of each month at the Behavioral Health Resource Center in Rialto. The Partnership facilitates better communication, planning, coordination, and cooperation among all entities that provide services and/or resources for the relief of homelessness in San Bernardino County.

Mission Statement

The Mission of the San Bernardino County Homeless Partnership is to provide a system of care that is inclusive, well planned, coordinated and evaluated and is accessible to all who are homeless and those at-risk of becoming homeless.

The HEAP grant in a cooperation with 6 other networks in the county and includes: <ul style="list-style-type: none"> ○ Rental assistance ○ Move in funds ○ Food vouchers • Mountain HC is working on housing including an emergency shelter, transitional housing, etc.

Don Smith, Director, SBC Pathways to Housing Network	Don Smith	<p>Don discussed the Homeless Emergency Assistance Program grant application he submitted to the county of which the Mountain HC is a part.</p> <ul style="list-style-type: none"> • \$9.3 million in one-time funding – our project is 29 of 33 in contention for funding • Pilot for Diversion activities which are cost effective, reduces barriers, and prevents homelessness (Impact SoCal model) <ul style="list-style-type: none"> ○ Meeting household's needs in the moment to prevent homelessness ○ Strengths based utilizing family resources and problem solving ○ Small investments with capped funds and allocations ○ Research alternative housing models such as shared housing ○ Align with the coordinated entry system – 211 • Mountain HC portion is \$150 K - \$4,000 in flexible funding, \$2,000 in admin costs • Need to look at sustainability including how to fundraise to maintain the program following end of grant funding. • Utilize resources from the county including KEYS – part of Transitional Assistance Dept., Workforce Development Dept. • Allows for real time data tracking which is important to meet program goals and efficacy • Request for Mountain HC partners to speak at the Interagency Council on Homelessness at their Nov. 28 meeting at Behavioral Health Auditorium in Rialto. 9:00 AM – 11:00 AM

They work with the Sheriff's HOPE team to engage homeless in accessing resources. • Entering information in the HMIS and app • Cost Share agreements for Forest Service work crews; assistance for Veterans • Access through CES with diversion programs for anyone who is literally homeless for 1 day. Must be a TAD recipient. No wrong door to access services. <ul style="list-style-type: none"> ○ Diversion Specialists ○ Interim housing ○ Advocating with landlords • Veteran's program • Employment resources for those receiving aid • 2 days in Twin Peaks • Have parents that lost their home in the Paradise fire • Opened and closed a shared housing facility <ul style="list-style-type: none"> ○ Closed due to lack of 3 families needed to maintain the home ○ Discussed a parent who is on disability with a foster child and 3 pets, needing a place to stay • Bonnie Shaffer considering being Big Bear representative to the Mountain HC. • Difference in the culture of Big Bear where the community doesn't recognize a housing/homeless issue • Continue to advocate for TAD services in Big Bear. Requested assistance from partners to advocate with county entities since 3rd District Supervisor Ramos was elected to the State Assembly • Start the process of Case Consults • Create a universal consent form • Start identifying needs and gaps and fund the gaps • Ensure knowing what resources and not put families in substandard housing • Mountain Issues: Up vs Down the mountain; East vs. West issues • Language is important: "Housing Choice" is client choice in housing • Need to find employers to buy in to the system of supports
