	CES Lead Agency to support the following CES
	enhancement, expansion, and software integration
	activities (in priority order):

- a. Establishing a CES Virtual Platform and other technological enhancements to support an end-to-end coordinated entry system workflow, from outreach to housing placement, and facilitate expanded, streamlined access to the CoC homeless response system for all system-users, collaborators, and other stakeholders.
- b. Establishing contractual relationships with service agencies designated to serve as regional and/or subpopulation CES entry points as outlined in the policy document by the CoC CES Oversight Committee.
- c. The development of **CES** information. education, training and service instruments, materials, and resources needed to support effective end-to-end system user engagement from outreach housing to placement.
- 2. Recommend the Office of Homeless Services (OHS) to seek County approval to initiate the contract development and execution process with Inland SoCal United Way (ISCUW 211+) and report back to the ICH with a timeframe to complete the process in time to meet CESH grant fund obligation requirements.
- 3. Charge the CES Lead Agency with continuing to work with the CES Oversight Standing Committee to develop a multi-year CES Budget Plan (Plan) and report back to the ICH within 60 days. The Plan will identify potential funding for sustaining the improvements created through the investment of the CESH funds. Exact budget line-item amounts to be determined during contract negotiations based on the priority order outlined above.

Reallocate \$75,000 of Homeless Housing, Assistance and Prevention (HHAP) Round 1 grant funding according to one of the following options or as may otherwise be directed by the Council	Tom Hernandez, Office of Homeless Services	Chair recognized Tom Hernandez, from OHS to present on the reallocation of Homeless Housing, Assistance and Prevention (HHAP) Round 1 grant funding. The Chair opened the item for comment by the ICH Board members. Discussion ensued: Ruben Mendoza–Requested for funds to be allocated to Family Assistance Program. Through personal

experience, Mr. Mendoza stated that this program serves in the city of San Bernadino and the High Desert to young adults between the ages of 18-24. Family Assistance Program provides assistance to young adults to assist them with getting back on their feet through a variety of different services: anger management, financial literacy workshops, and mock interviews.

- Sandra Ibarra Requested more information on what services Family Assistance Program is providing to the youth.
 - Tom Hernandez A minimum of 8% from the CoC of HHAP funding is allocated to youth related services. These HHAP funds must go to youth related services to be provided county wide. HHAP round 1 total awarded funds were just under 3 million to be distributed. HHAP round 3 & 4 will be at a 10 % minimum. Services provided are supportive services for runaway, homeless youth, emergency shelter, transitional housing, and rapid rehousing. Family Assistance Program, formerly known as the High Desert Domestic Violence Program, has been an integral member of CoC active members since the homeless coalition and has been a recipient of 2 million dollars a year of CoC award funding as part of the domestic violence coalition.
- Antionette Jackson Would like for the Desert Region Steering Committee (DRSC) to recommend what
 entity in the HHAP round 1 qualifies and for the DRSC to have a discussion as to how those funds will be
 spent. Ms. Jackson recommended that if the committee is unable to determine an entity, then consider the
 option to put out an RFP for other entities that need the funding.
- Pastor Sharon Green Agreed that the funds should go back to the desert.
- Brenda Dowdy Would like for funds to be allocated to Family Assistance Program.
- Don Smith Mentioned that the Family Assistance Program has been premier with youth servicing in the state. Mr. Smith would not oppose funds being allocated to Family Assistance Program but would like a deliberative/strategic approach to be put in place. Believes it is appropriate for funds to be sent back to the Desert Region and for them to come back with recommendations and would support a motion to that affect.

Chair opened the item for public comment.

Discussion ensued:

- ZaZette Scott Ms. Scott asked what agencies would be awarded the HHAP round 1 funding.
 - Jessica Alexander responded that she is unsure which agencies would qualify for the funding and will need to see where the motion goes.
- Eugene Butticci, from Desert Manna In favor of option 2, as funding was originally allocated to the Desert Region and would like for funds to remain there.
- Dr. J. Sanquist Mentioned that he really likes the Family Assistance Program and believes that they will do a great job with utilizing the money and wouldn't like to lose these funds by going back and forth. Dr. Sanquist asked if the High Desert would be able to use these funds if the money is allocated to them.

Authorize the Office of Homeless Services (OHS) to initiate and administer the following HHAP-3 funded contract award recommendations through San Bernardino County	Tom Hernandez, Office of Homeless Services	Chair recognized Tom Hernandez, from OHS to present on recommendations for the reallocation of Homeless Housing, Assistance and Prevention (HHAP) Round 3 grant funding. Mr. Hernandez gave a brief overview of the item. The Chair then recognized Don Smith to provide alternative resolutions with discussion as to how these recommendations were brought about. Don Smith made a motion to: 1. Establish a HHAP-3 Implementation & Oversight Committee, with at least one representative from each region, to work with the Office of Homeless Services (OHS), as the CoC designated HHAP-3 Administrative Entity, on the implementation of HHAP-3 system support activities and the project funding application process. 2. Authorize the HHAP-3 Implementation & Oversight Committee and OHS to initiate the Systems Improvement and Supports activities approved by ICH with the 20% initial disbursement of HHAP-3 funds, \$780,374.96, which include: a. \$300,000 for Capacity Building/Workforce Development activities for system service providers b. \$200,000 for Systems support activities necessary to create regional partnerships and maintain a homeless services & housing delivery system. c. \$147,711 to address racial disproportionality in homeless populations and achieve equitable provision of services and outcomes. d. \$78,037.50 to support development of the CoC Youth Advisory Board and youth-specific coordinated entry system activities 3. RECOMMENDATIONS

That the SBC&C CoC Interagency Council on Homelessness (ICH) take action to initiate the CoC CES Oversight Standing Committee immediately; and

That the ICH consider including representatives from the CES Policy Ad Hoc Committee, completing its charge in February, 2023, for CoC CES Oversight Committee membership.

BACKGROUND INFORMATION

In 2022, Interagency Council on Homelessness (ICH) created an Ad Hoc Coordinated Entry System (CES) Review Committee. The work of the committee resulted in an extensive report with multiple recommendations in five key areas: system design, operations, policies and procedures, funding, and planning and system transition. Together, the recommendations proposed a re-imagined CES that: incorporates additional formal partners in many system processes; offers a regional design with subregional structures; embraces efficient assessment, referral and placement processes; underscores the importance of ensuring consistent implementation some system activities such as case conferencing; calls for articulation of responsibilities among CES structural components; identifies the need for an ongoing source of funding for system implementation; and sets expectations for system operations, review and reporting.

The ICH received the Ad Hoc CES Review Committee report in a special meeting in August, 2022 and subsequently adopted the recommendations in September, 2022. The recommendations included: "To strengthen governance, the ICH should establish a CoC CES Standing Committee responsible for oversight of the CES operations and the ongoing development of policies and procedures for evaluating regulatory compliance."1

Subsequently, the CES Policy committee was formed to update the CES Guidebook to advance the recommendations adopted by the ICH. At this time, the CoC CES Policy Ad Hoc Committee is recommending that the SBC&C CoC Interagency Council on Homelessness (ICH) take immediate action to seat a CES Oversight Standing Committee to assume the ongoing tasks associated with CES development and evaluation.

RECOMMENDATION

Approve the reallocation of \$75,000 in HHAP Round 1 funding originally allocated to Illumination Foundation to the Family Assistance Program for the provision of youth-related services per recommendation by the Interagency Council on Homelessness (ICH) Desert Regional Steering Committee.

BACKGROUND INFORMATION

On December 6, 2019, the State of California Homeless Coordinating and Financing Council (HCFC), now known as the California Interagency Council on Homelessness (Cal ICH), released the Notice of Funding Availability (NOFA) for the HHAP program. HHAP Round 1 was a \$650 million block grant program authorized by AB 101 (Committee on Budget, Chapter 159, Statutes of 2019) and designed to provide jurisdictions with one-time grant funds to support regional coordination and expand or develop local capacity to address immediate homelessness challenges throughout the State.

On February 11, 2020 (Item No.26), the Board of Supervisors approved the submission of an application allowing the County to apply for both the San Bernardino County Continuum of Care (CoC) grant allocation of up to \$3,071,060 and the San Bernardino County grant allocation of up to \$2,865,015. Both applications were approved by the State. The San Bernardino County CoC grant totaling \$3,071,060 was based on the total number of homeless counted during the 2019 Point-In-Time Count.

On September 3, 2020, the Office of Homeless Services (OHS) released a Request for Applications (RFA) for the HHAP Program. The Application submittal deadline was Thursday, September 24, 2020, by 4:00 p.m. (local time).

The Regional Steering Committees (RSC's) held meetings to determine priorities for their regions. The priorities were incorporated into the RFA. Separate evaluation meetings were scheduled for each region. The non-conflicting members of the RSC's individually reviewed and scored the applications for their region. During the scheduled public meetings held October 13 through 22, each evaluator provided their scores for each application and the rankings were determined. The RSC non-conflicting voting members made recommendations for contract awards and funding.

On October 22, 2020, notifications were sent to applicants informing them of the tentative recommendations made by the RSC's. The deadline for the applicants to accept or appeal the tentative recommendations was no later than 9:00 p.m. on Sunday, October 25, 2020.

As part of the Desert RSC, Illumination Foundation was recommended for a \$75,000 allocation of funding to be used to provide Rental Assistance and Rapid Re-Housing services to include: housing identification, rent, utilities and utilities arrears, furnishings, intensive case management services, and housing navigation services to individuals who are experiencing homelessness. The primary beneficiaries of the project were to be adult individuals who are experiencing homelessness in the Desert Region.

On November 2022, OHS was informed by Illumination Foundation they were returning the full unspent amount of \$75,000 to be repurposed. The original contract grant term was from January 26, 2021, through June 30, 2025.

On January 25, 2023, the OHS provided ICH 3 options for reallocation of the \$75,000. Option 1 included reallocating the \$75,000 to Family Assistance Program for the provision of youth-related services as they have already fully expended their HHAP Round 1 youth set-aside, Option 2 included allowing the Desert Regional Steering Committee to repurpose the \$75,000 for the Desert Region by asking the Office of Homeless Services to request applications to solicit new providers to apply for the \$75,000, and Option 2 was to allow the Desert Regional Steering Committee to re-distribute the \$75,000 to one or more of the previously recommended HHAP Round 1 providers.

The ICH voted to allow the ICH Desert Regional Steering Committee to determine how they wanted to proceed in the reallocation of the \$75,000 at their next regularly scheduled meeting and to return the recommendation back to the full ICH at the next regularly scheduled meeting of the ICH.

On February 14, 2023, the ICH Desert Regional Steering Committee met to discuss the reallocation of the \$75,000 in HHAP Round 1 funding and the following action was determined via roll call vote by the Committee: recommend the reallocation of the \$75,000 from Illumination Foundation to Family Assistance Program for the provision of youth-related services. Eight members were in attendance. The following votes were placed, 7 members voted yes, 1 member voted no, with zero abstentions, the motion passed.

Housing (CESH) Round 1 & 2 Funding Allocated by the CoC for CES Enhancements, Expansion

and Software Integration

RECOMMENDATIONS

Adopt the following recommendations for the obligation and expenditure of the \$653,419 in CESH Round 1 and 2 grant funding allocated by the CoC for "systems support necessary to maintain a comprehensive homeless and housing service delivery system" and specifically earmarked for CES enhancement, expansion, and software integration.

- 1. Allocate the \$653,419 in CESH grant funding to the CoC CES Lead Agency to support the following CES enhancement, expansion, and software integration activities (in priority order):
 - a. Establishing a CES Virtual Platform and other technological enhancements to support an endto-end coordinated entry system workflow, from outreach to housing placement, and facilitate expanded, streamlined access to the CoC homeless response system for all systemusers, collaborators, and other stakeholders.
 - b. Establishing contractual relationships with service agencies designated to serve as regional and/or subpopulation CES entry points as outlined in the policy document by the CoC CES Oversight Committee.
 - c. The development of CES information, education, training and service tools, instruments, materials, and resources needed to support effective end-to-end system user engagement from outreach to housing placement.
- Recommend the Office of Homeless Services (OHS) to seek County approval to initiate the contract development and execution process with Inland SoCal United Way (ISCUW 211+) and report back to the ICH with a timeframe to complete the process in time to meet CESH grant fund obligation requirements.
- 3. Charge the CES Lead Agency with continuing to work with the CES Oversight Standing Committee to develop a multi-year CES Budget Plan (Plan) and report back to the ICH within 60 days. The Plan will identify potential funding for sustaining the improvements created through the investment of the CESH funds. Exact budget line-item amounts to be determined during contract negotiations based on the priority order outlined above.

BACKGROUND INFORMATION

The CESH grant program was established by State of California statute to provide localities with one-time flexible block grant funds to address their immediate homelessness challenges. The state allocated two

rounds of CESH funding to the City and County of San Bernardino CoC – Round 1 in the amount of \$1,459,234 and Round 2 in the amount of \$835,711.

Allocated funds must be used to carry out one or more of the eligible activities identified in Section 50490.4, subdivision (a), which include:

- 1. Rental assistance, housing relocation and stabilization services
- 2. Operating subsidies for permanent housing in the form of 15-year capitalized operating subsidy reserve (COSR)
- 3. Flexible housing subsidy funds to support the provision of rental subsidies in permanent housing
- 4. Operating support for emergency housing interventions, and
- 5. Systems support for activities necessary to maintain a comprehensive homeless services and housing delivery system, including CES data, HMIS reporting, and homelessness planning activities.

In addition, Section 50490.3, subdivision (a)(3)(B) of the CESH statues state that "a minimum of 20 percent of the allocation to the CoC service area will used to implement or update its systems to comply with" applicable HUD CES and HMIS requirements.

On September 19, 2018, the ICH approved the allocation of approximately 35% of the CESH Round 1 funding (\$486,272) towards systems support activities necessary for CES enhancement, expansion, and software integration. On April 24, 2019, the ICH approved the allocation of approximately 20% of the CESH Round 2 funding (\$167,147) towards systems support activities necessary for CES enhancement.

The CoC Ad Hoc Committee on CES Policies and Procedures is recommending that the CESH funding allocated by the ICH for systems support for activities necessary to maintain a comprehensive homeless services and housing delivery system continue to be dedicated to coordinated entry system expansion and software integration and obligated to the CoC Lead Agency to support the activities described in the recommendation section above.
