- Carina Villalpando from the City of Colton had a question and asked for assistance regarding HMIS reporting. She was referred to the proper contact person.

- A **HHAP 3** update was given by Anna Ulibarri. Anna reported that the committee was finalizing the RFP's for:
  - Capacity Building RFP 23-02 – will be released within the next week or so.

- Strategic Planning & Systems Support RFP 23-03 – Is being revised and sent to purchasing for final review. The anticipated release date will be the end of September, early October.
- Racial Equity Analysis RFP 23-04 – is also in the revision process and the anticipated release date will be early October.
- **HHAP 4** – At the October meeting a determination will be made on how the HHAP 4 funds will be distributed by region. Of the several options presented, Central Valley is recommending that the funds be distributed by the PIT count with no modifications. Central Valley has the greatest homeless population and the greatest needs.
- **HHAP 5** - The committee is working with the OHS and Chief Marcus Dillard to develop the Local Action Plan with specific outcome goals that are required for the HHAP 5 application.
- **Regional Access Centers** – Aziza Manuel from Inland So Cal United Way made an appeal to all partner agencies to apply for the funding allocated for the Central Valley for their RAC. At this time no agency has applied for the funding, and we are the only region without applicants to be considered.

**PRESENTATION:**

- **Healthcare in Action** – Gave a wonderful presentation on “Street Medicine” and how they have partnered with the City of San Bernardino to meet the medical needs of the homeless population in the city. Eddie Menacho is the PA who is leading the team, and he presented the history of how “Street Medicine” evolved and the numerous hospitals and agencies he has worked with to get to where he is today. They take a servant pose when doing outreach and are having success in building relationships and providing medical attention right where the need is – on the street. Their contact information is:

She also informed the audience that the County of San Bernardino is taking applications for new housing development with funding they set-aside from their initial \$72 million dollar set-aside to combat homelessness. The agency must partner with their local city to apply for the funding.
- Family Assistance Program reported that their Tiny Home Village in Victorville in development and exited for the housing that it will provide for homeless youth. They are also exploring partnerships with community colleges.
- Dr. Rene Keres reported out on what InnRoads is doing in the region and is excited to connect with Healthcare in Action to partner with them on the “Street Medicine” efforts.

Charles Darbee provided an update at the previous meeting and the meeting opened for public comment/questions. An RFP was released last month for agencies who are interested in taking on the role of regional Access Centers in each region. There were zero applicants from the Central Valley, so she was invited back today.</p> <p>Today Aziza reported the following today:</p> <ul style="list-style-type: none"> <li>- The goal is the Access Center is to create a hub or one-stop shot for our clients.</li> <li>- CES will partner with the hub to facilitate connecting clients to what they need a lot faster.</li> <li>- The idea is for the partner to augment what the providers are already doing by offering the one on one support.</li> <li>- She acknowledged that the funding is not a lot of money; however, the providers are already doing the work, and this will allow agencies to hire dedicated staff for outreach to provide homeless verifications for instance because the CES team is small, and this creates delays.</li> <li>- Case conferencing with CES will assist in identifying clients' resources and delivering them to their resources by sharing information.</li> </ul>
