Our team is funded by 211 to verify homeless callers, ensure they are in HMIS and navigate them to shelter or housing

Our workflow is

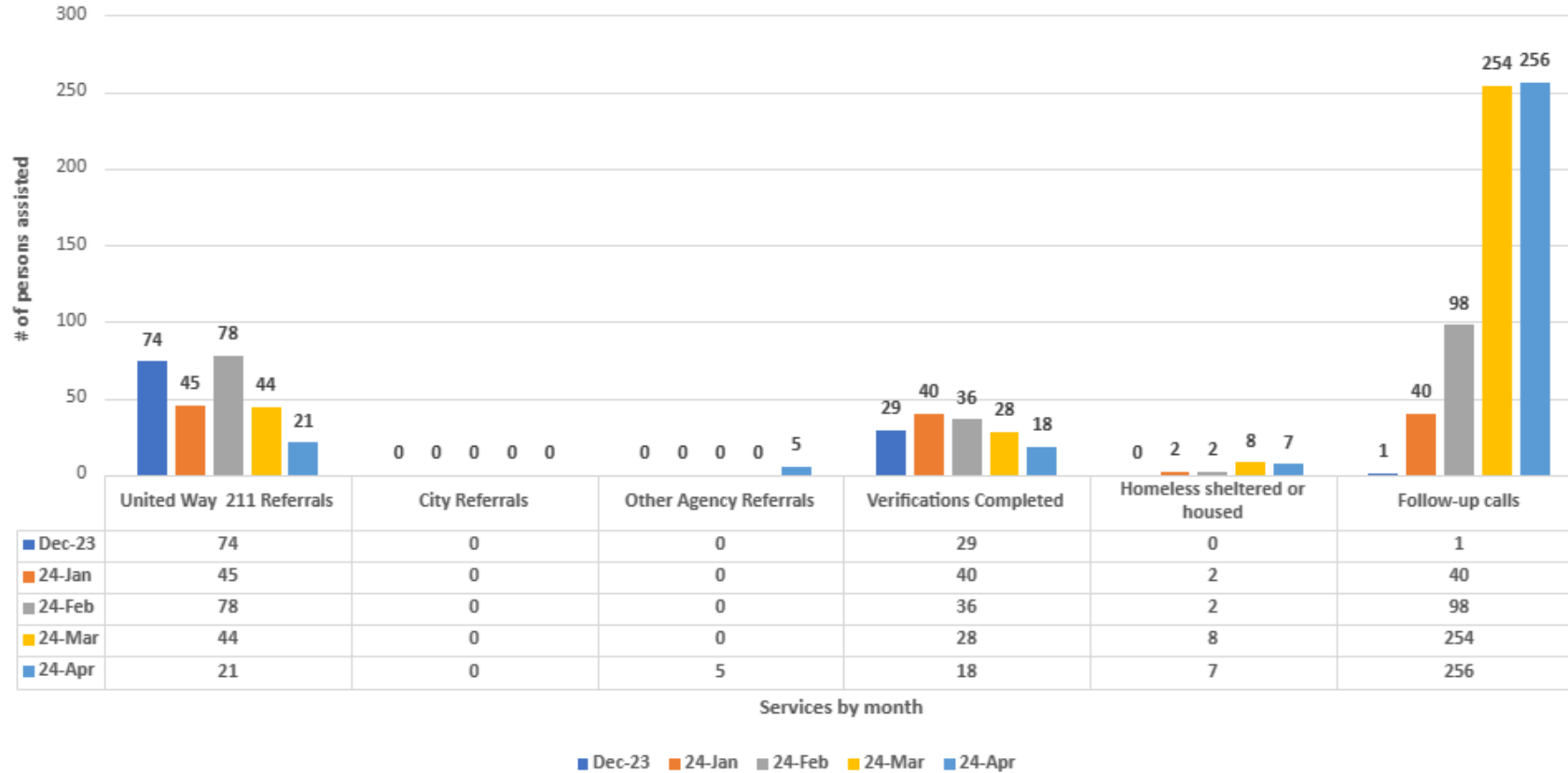
1. Persons in crisis phone 211 and 211 **completes a VI-SPDAT on them**, refers them to us.
2. We act on referrals as they arrive..... typically, within hours of receiving.
3. We verify homeless - (1) in field and (2) in office and (3) by telephone. Most verifications are done “in the field” with an assessment form.
4. We “upload” homeless verifications into HMIS our county-wide database of homeless.
5. We email 211 confirmations verification is complete and in HMIS. We do this every day - M-F 8am-5pm.
6. We navigate some homeless to shelter or housing.
7. We track the work so it can be reported.

The volume of 211 referrals we receive each month varies and that impact the volume of verifications we complete

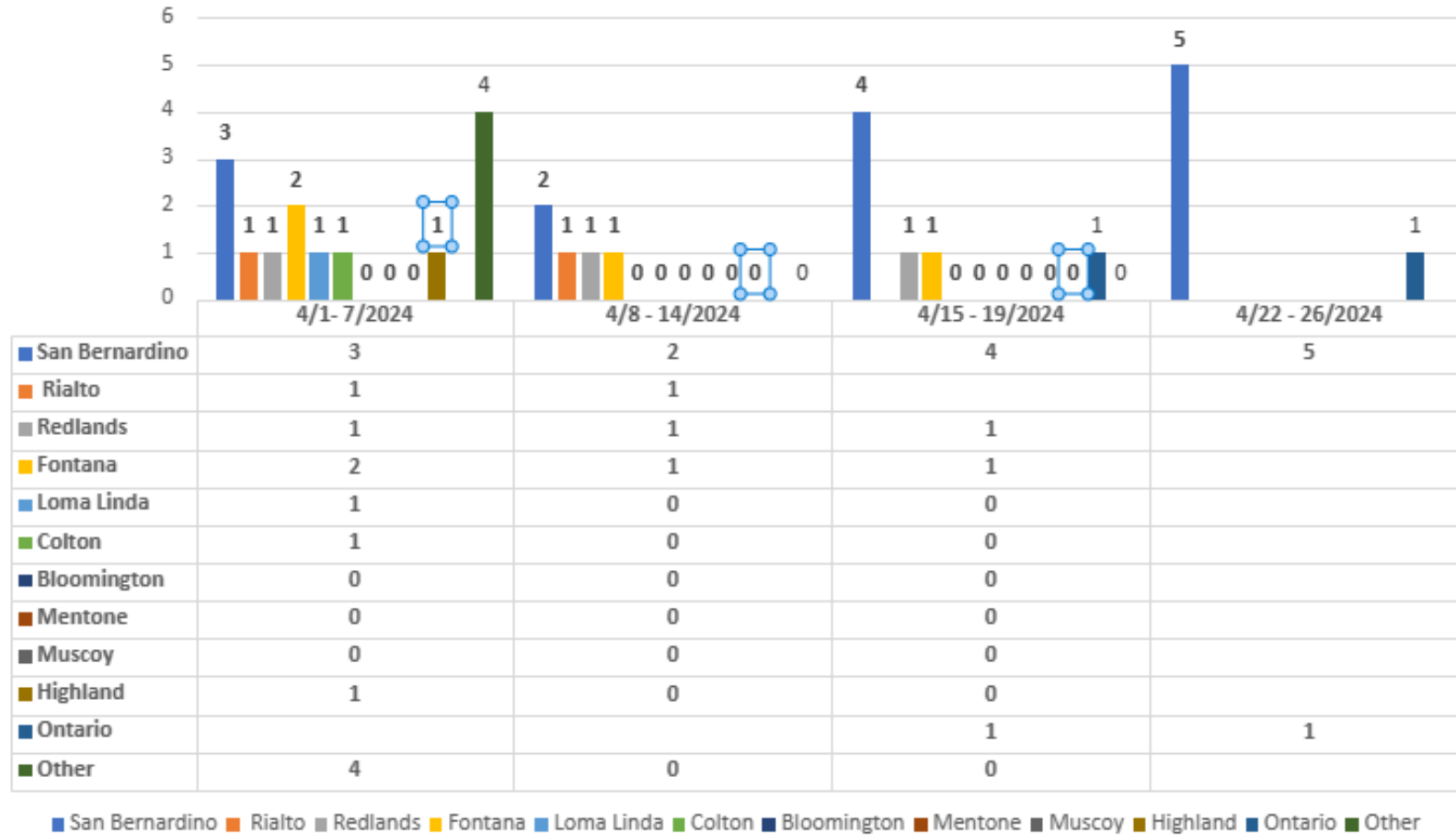
The team is improving the number of homeless they can navigate to shelter and provide follow-up calls to

April 2024 Homeless Referrals by Central City



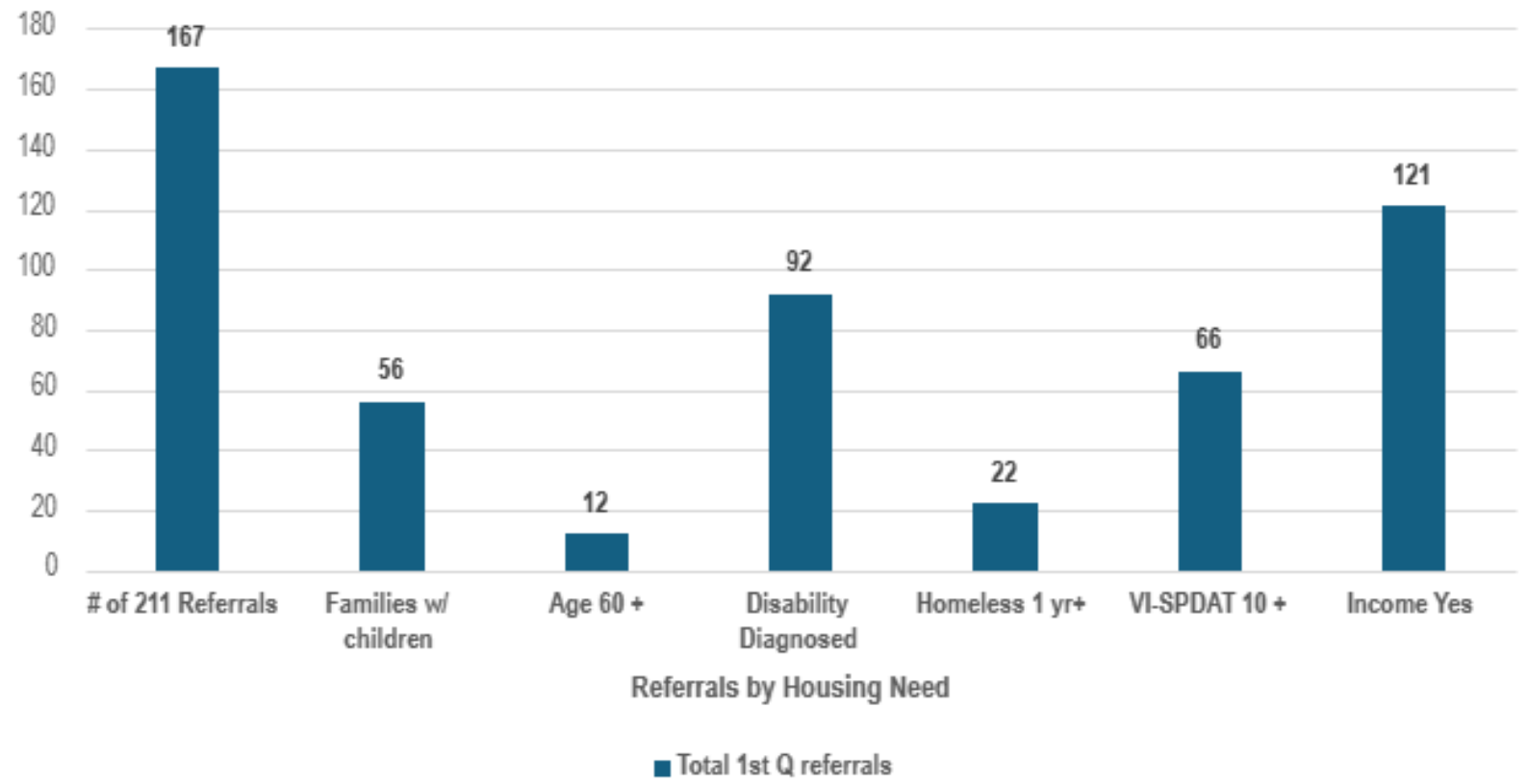
Cities with highest homeless callers in April are San Bernardino (14) Fontana (4) Other (4) and Redlands (3)

Analysis of 211 Central Homeless Referrals for 1st Q 2024



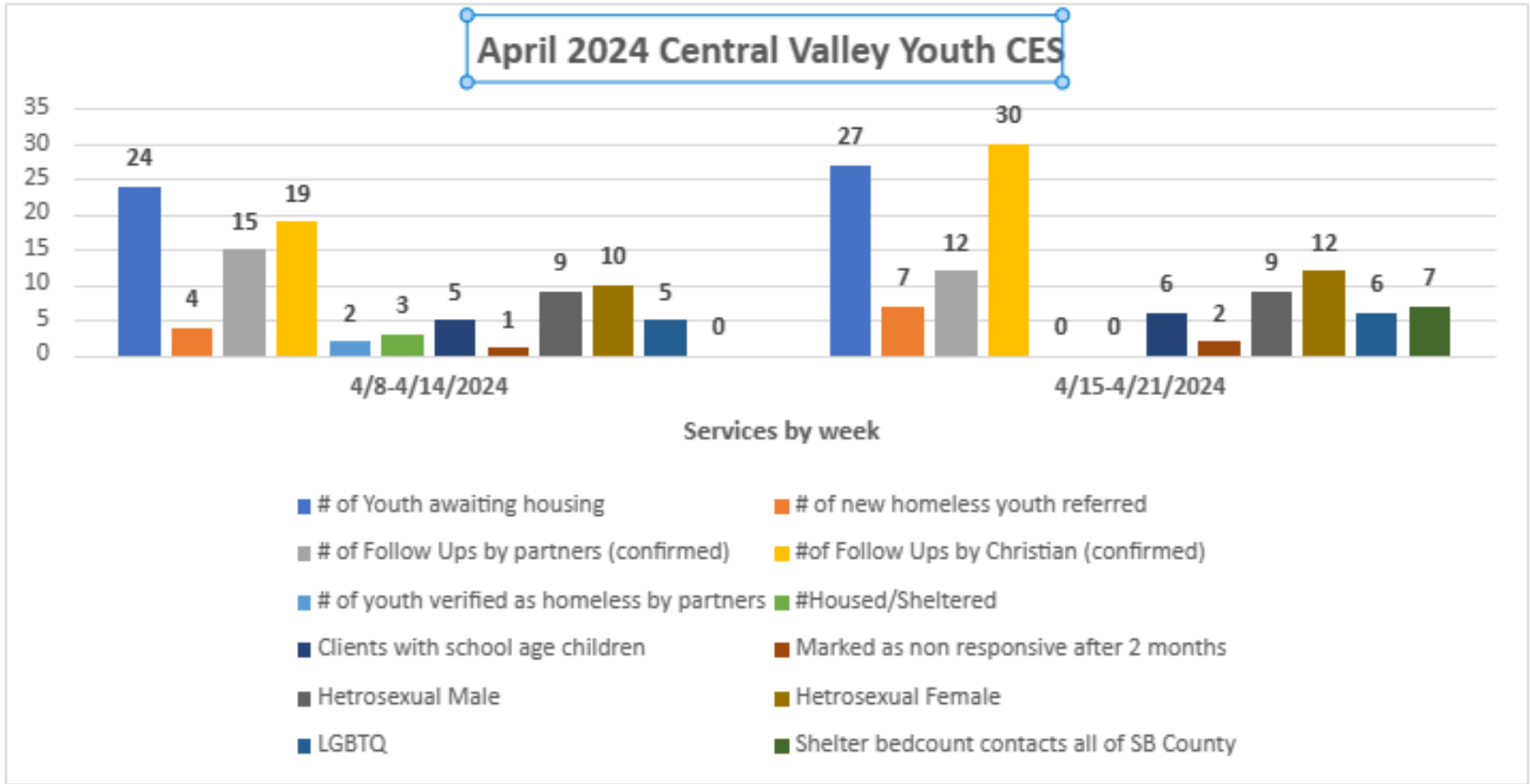
A high percentage (121 out of 167 referrals report YES to income with 92 self reporting disability (mental health) and 66 having a VI-SPDAT score of 10+.

Hope is this assessment supports committee discussion on grants and types of programs requiring expansion - family shelter, PSH, affordable housing etc.
