Social Disparity - Society, social inclusion, and secondary socialization	Vincent Salazar, MPH Founder and Director, Rise Up for Global Action	Mr. Salazar presented some experience and research on working with the homeless, regarding primary and secondary socialization. In summary: Just giving beds, food and jobs training without addressing the psychological/sociological health of the individuals, collectively, overlook those important needs. Building a sense of community coming out of homelessness is important, otherwise they may be tempted to revert to a stronger sense of community among the homeless.
